

Take notice that Toronto City Council intends to partially repeal City of Toronto By-law No. 468-91, designating the properties at 50 St. Joseph Street (Cloverhill Wing, St. Michael's College) and 1, 3 and 5 Elmsley Place under Part IV, Section 29 of the Ontario Heritage Act, and to amend the same to revise the Reasons for Designation in accordance with the 2005 amendments to the Ontario Heritage Act.

Reasons for the partial repeal and amendment of the designating by-law

As the result of amendments to the Official Plan and Zoning By-law for the property at 50 St. Joseph Street, it is necessary to partially repeal By-law No. 468-91 to remove the designation from the parts of the site approved for redevelopment, which are legally described as Plan 66R-16274, Parts 2, 3, 12 and 13, from Schedules "A" and "C". The By-law is being amended further to reflect the 2005 amendments to the Ontario Heritage Act by revising the Reasons for Designation to include statements of the cultural heritage values of the properties at 50 St. Joseph Street (Cloverhill Wing, St. Michael's College) and 1, 3 and 5 Elmsley Place and descriptions of their heritage attributes.

Any person may object to the proposed partial repeal of the designating by-law by serving notice of an objection to the proposed partial repeal and amendment of the designating by-law on the City Clerk, Attention: Rosalind Dyers, Administrator, Toronto and East York Community Council, Toronto City Hall, 100 Queen Street West, 2nd floor, Toronto, ON M5H 2N2, within thirty days of the publication of this notice on the City's website, which is November 24, 2010. The notice of objection must set out the reason(s) for the objection, and all relevant facts.

The owner of the subject property may object to the proposed revisions to the reasons for designation by serving notice of an objection to the proposed revisions on the City Clerk, Attention: Rosalind Dyers, Administrator, Toronto and East York Community Council, Toronto City Hall, 100 Queen Street West, 2nd floor, Toronto, ON M5H 2N2, within thirty days of receipt of this notice, which is November 24, 2010. The notice of objection must set out the reason(s) for the objection, and all relevant facts.
