THE CORPORATION OF THE TOWN OF GODERICH BY-LAW NO. 5 OF 2014

A BY-LAW TO DESIGNATE A COPPER BEECH TREE AS A HERITAGE SIGNIFICANT TREE PURSUANT TO SECTION 29 OF THE ONTARIO HERITAGE ACT, R.S.O. 1990, CHAPTER 0.18, AS AMENDED, LOCATED IN THE NORTHWEST CORNER AT 8 ELGIN AVENUE EAST

WHEREAS the Ontario Heritage Act, R.S.O. 1990, Chapter 0.18, as amended, authorizes Council of a municipality to enact by-laws to designate real property, including all the buildings and structures thereon to be of cultural heritage value or interest;

AND WHEREAS the Council of the Corporation of the Town of Goderich has cause to be served upon the owner of the land and premises of a Copper Beech Tree located at 8 Elgin Avenue East located in the northwest corner of the property, Goderich, and upon the Ontario Heritage Trust Notice of Intent to Designate this real property and has caused such Notice of Intent to be published in a newspaper having a general circulation in the municipality;

AND WHEREAS no Notice of Objection to the said proposed designation has been served upon the Clerk of the Municipality.

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWN OF GODERICH ENACTS AS FOLLOWS:

- 1. That all real property, described as a Copper Beech Tree located at 8 Elgin Avenue East in the northwest corner of the property, Goderich, Ontario is designated as being of cultural heritage value or interest.
- 2. That the property owner and the Ontario Heritage Trust have been notified of the Notice of Intent and will be notified of the Notice of Passing.
- 3. That the Town Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described as Plan 457 Pt Lot 318, Town of Goderich, County of Huron, 8 Elgin Avenue East, Goderich, Ontario, in the land registry office.
- 4. That the Town Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the property described as a Copper Beech Tree located at 8 Elgin Avenue East, Goderich, Ontario and upon the Ontario Heritage Trust and to cause notice of this by-law to be published in a newspaper having a general circulation in the Town of Goderich.
- 5. That the Ontario Heritage Trust add the Cooper Beech Tree located at 8 Elgin Avenue East to the Provincial Registry and Municipal Registry.
- 6. That a copy of the Notice of Intent to Designate is hereby appended.

READ A FIRST, SECOND AND THIRD TIME AND FINALLY PASSED THIS 13th DAY OF JANUARY, 2014.
