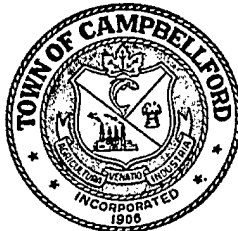

NOTICE OF PASSING OF BY-LAW

Take Notice that the Council of the Corporation of the Town of Campbellford has passed by-law number 1983-22 to designate the Old Campbellford Firehall on Saskatoon Avenue (Part Lot 7, East Factory Block, Plan 112) as being of architectural and historical value or interest under Part IV of the Ontario Heritage Act, RSO 1980, Chapter 337.

BY-LAW # 1983-22

Being a by-law to designate the Property known as the Old Campbellford Firehall (part Lot 7, East Factory Block, Registered Plan 112) as being of Architectural and Historical value or interest.

WHEREAS Section 29 of the Ontario Heritage Act 1974 authorizes the Council of a municipality to enact by-law to designate real property including all buildings and structures thereon to be of architectural or historic value or interest

AND WHEREAS the Council of the Corporation of the Town of Campbellford is the owner of the said property known as the Campbellford Firehall and has caused to be served on the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks


AND WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the municipality.


THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF CAMPBELLFORD ENACTS AS FOLLOWS:-

1. There is designated as being of architectural and historical value of interest the real property known as the Old Campbellford Firehall on Saskatoon Avenue more particularly described as Part of Lot 7, East Factory Block Registered Plan 112 of the Town of Campbellford.
2. The municipal solicitor is hereby authorized to cause a copy of this by-law to be registered against the property as described in section 1 in the registry office of Northumberland East.
3. The Clerk is hereby authorized to cause a copy of this by-law to be served on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

By-law read a first and second time this, 19th day of September 1983.
