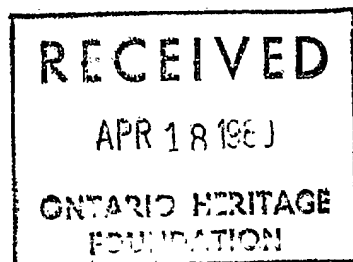

Re: The John Jerman House  
Municipally known as 16 Wellington Street

This will advise that the Council of the Town of Markham at its meeting held on January 24th, 1989 had before it for consideration a letter dated January 16th, 1989 from the owner, [REDACTED], High Meadow Limited In Trust requesting that By-law 4-89 being a by-law to designate the John Jerman House at 16 Wellington Street, Markham as a property being of historic and/or architectural value or interest, be repealed.

I would advise that Council at that time received the letter and that in accordance with Section 32(1) of the Ontario Heritage Act such matter was referred to Heritage Markham for a report and recommendation to Council to be submitted not later April 11th, 1989.

I would advise that Council at its meeting held on April 11th, 1989 passed the following resolution with respect to the request of Mr. Fine, viz.:

"RESOLVED THAT the resolution passed by Heritage Markham at its meeting held on March 15th, 1989 requesting that Council confirm its decision to designate the John Jerman House, 16 Wellington Street, under the Ontario Heritage Act, be received;

AND THAT the request of Mr. Gary Fine, High Meadow Limited In Trust, that By-law 4-89 being a by-law to designate the John Jerman House at 16 Wellington Street, Markham as a property being of historic and/or architectural value or interest be repealed, be not approved;

AND THAT pursuant to Section 32(2)(a) of the Ontario Heritage Act, notice of the decision of Council be given to the owner and to The Ontario Heritage Foundation."

For your information I have advised Mr. Fine that pursuant to Section 32(4) of the Ontario Heritage Act the owner may within 30 days after receipt of the notice under Subsection (2) apply to the Council for a hearing before the Conservation Review Board.


