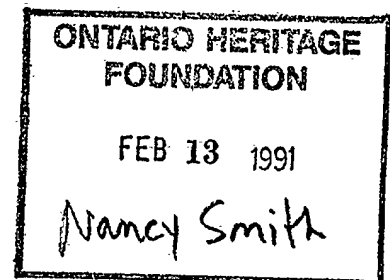

This will advise that Council at its meeting held on January 29th, 1991 passed the following resolution with respect to the application for issuance of a demolition permit for the Steckley (Doner) Farmhouse, north side of 19th Avenue, east of Woodbine Avenue, viz.:


"RESOLVED THAT the report dated January 21st, 1991 from the Director, Building Services, advising of an application received for the demolition of the Steckley Doner Farmhouse, Concession 4, Part Lot 31, north side of Nineteenth Avenue, east of Woodbine Avenue, be received;

AND WHEREAS Huang and Danczkay International Inc. have applied for the issuance of a demolition permit on November 13th, 1990 for the demolition of a heritage building designated by Town of Markham By-Law No. 82-90 under the provisions of the Ontario Heritage Act being the Steckley Doner Farmhouse, being Part of Lot 31, Concession 4;

NOW THEREFORE BE IT RESOLVED THAT the application of Huang Danczkay International Inc. for the issuance of a demolition permit for the Steckley Doner Farmhouse located at Concession 4, Part Lot 31, be refused and Council hereby prohibits any work to demolish or remove any building or structure on the property for a period of 180 days from the date of this meeting of Council pursuant to Section 34(2)(b) of the Ontario Heritage Act."
