

CORPORATION OF THE CITY OF CAMBRIDGE

Being a by-law of the Corporation of the City of Cambridge to designate the Gore Tower structure located in Centennial Park at 170 Main Street as a property of cultural heritage significance.

WHEREAS the Ontario Heritage Act, R.S.O. 2005 Chapter 0.18 authorizes the Council of a municipality to enact by-laws to designate real property including all buildings and structures thereon, to be of cultural value or interest;

AND WHEREAS Notice of Intention to Designate the Gore Tower in Centennial Park at 170 Main Street, Cambridge, Ontario, have been duly published and served;

NOW THEREFORE BE IT RESOLVED THAT the Corporation of the City of Cambridge enacts as follows:

- 1. THAT there is designated, as being of cultural heritage significance, the exterior of the structure located on the real property, more particularly described in Schedule "A" attached hereto, known as the Gore Tower in Centennial Park, 170 Main Street, Cambridge, Ontario. The reasons for designation are as set out in Schedule "B" attached hereto;
- 2. THAT the City of Cambridge is hereby authorized to cause a copy of this by-law to be served upon the owner of the said property and upon the Ontario Heritage Trust and to cause notice of this by-law to be published in a newspaper having general circulation in the City of Cambridge.
- 3. THAT it is Acknowledged and Directed that the office of the City Solicitor, or his/her designate, be authorized to register electronically any and all documents in connection with this transaction.
- 4. THAT this by-law shall come into full force and effect upon the final passing thereof.

The Gore Tower in Centennial Park, municipally known as 170 Main Street, was designated because of its cultural heritage significance.

Description of Property

The subject structure is circular tower topped by copper cupola set on eight pillars and stands approximately two storeys high. It is located in Centennial Park, close to the Spruce Street entrance.

Statement of Cultural Heritage Value or Interest

The Gore Tower was constructed in 1895 and was the central feature of the Gore Insurance building at the corner of Ainslie Street and Main Street. The building and its tower with cupola were designed by local architect Fred Mellish and constructed by contractors W. and F. A. Scott. The Gore Insurance building was demolished in 1971 but the Tower was saved, restored and stored privately until it was put on permanent display in Centennial Park in 1981. The copper and wood constructed Gore Tower was considered to be one of the finest tower and cupolas in the area.

Description of Heritage Attributes

The key exterior attributes which characterize the cultural heritage value of the Gore Tower located in Centennial Park at 170 Main Street are the:

- · location in Centennial Park near the Shade Street entrance;
- hand molded metal panels and fixtures on the cupola;
- · hand molded columns supporting the cupola on the tower portion;
- the spire above the cupola;
- · wood structural frame under the moldings and copper
- copper sheeting on the tower support
- copper eavestroughs
