By-Law 2018-97**

Being a By-Law to amend The Township of Delhi By-Law No. 35-92, designating the property known municipally as Lot 23, Block 19, Plan 189 Township of Delhi, 329 Queen Street, Delhi.


WHEREAS The *Ontario Heritage Act*, R.S.O. 1990, and amendments thereto, Chapter 0.18, Section 29 authorizes the council of a municipality to enact by-laws to designate real property including all buildings and structure thereon to be of architectural or historic value or interest.

AND WHEREAS the Council of The Corporation of Norfolk County deems it necessary that Schedule B of the Township of Delhi By-Law 35-92 be hereby amended by deleting all references to the west, south and east elevations.


NOW THEREFORE the Council of The Corporation of Norfolk County hereby enacts as follows:
