THE CORPORATION OF THE TOWN OF MARKHAM
BY-LAW NUMBER 269-86

A by-law to designate an area of the Town as a heritage conservation district.

WHEREAS the Council of the Town of Markham under Section 40 of Part V of the Ontario Heritage Act, R.S.O., 1980, c.337 has by By-law No.180-76 defined the Thornhill Heritage Conservation Study Area as an area to be examined for future designation as a heritage conservation district;

AND WHEREAS the examination of the Thornhill Heritage Conservation Study Area has now been completed;

AND WHEREAS Section 41 of the said Ontario Heritage Act enables the council of a municipality to designate by by-law an area as a heritage conservation district, where there is in effect in a municipality an official plan that contains provisions relating to the establishment of heritage conservation districts;

AND WHEREAS the Official Plan of the Town of Markham Planning Area contains provision for the designation of heritage conservation districts;

NOW THEREFORE the Council of the Corporation of the Town of Markham enacts as follows:

1. The area known as the Thornhill-Markham Heritage Conservation District-bounded on the west by Yonge Street, on the north by the height of land above the Don River, on the south by the back lot lines of properties on the south side of John Street, and on the east by the Don River's crossing at John Street; but excluding those properties which are designated under Part IV of the Ontario Heritage Act and excluding the Thornhill Summit Condominium property; and as illustrated in Schedule "A" attached hereto - be designated as a heritage conservation district.
2. This by-law does not come into force until approved by the Ontario Municipal Board.

READ a first and second time this 15th day of July, 1986.

READ a third time and passed this 15th day of July, 1986.

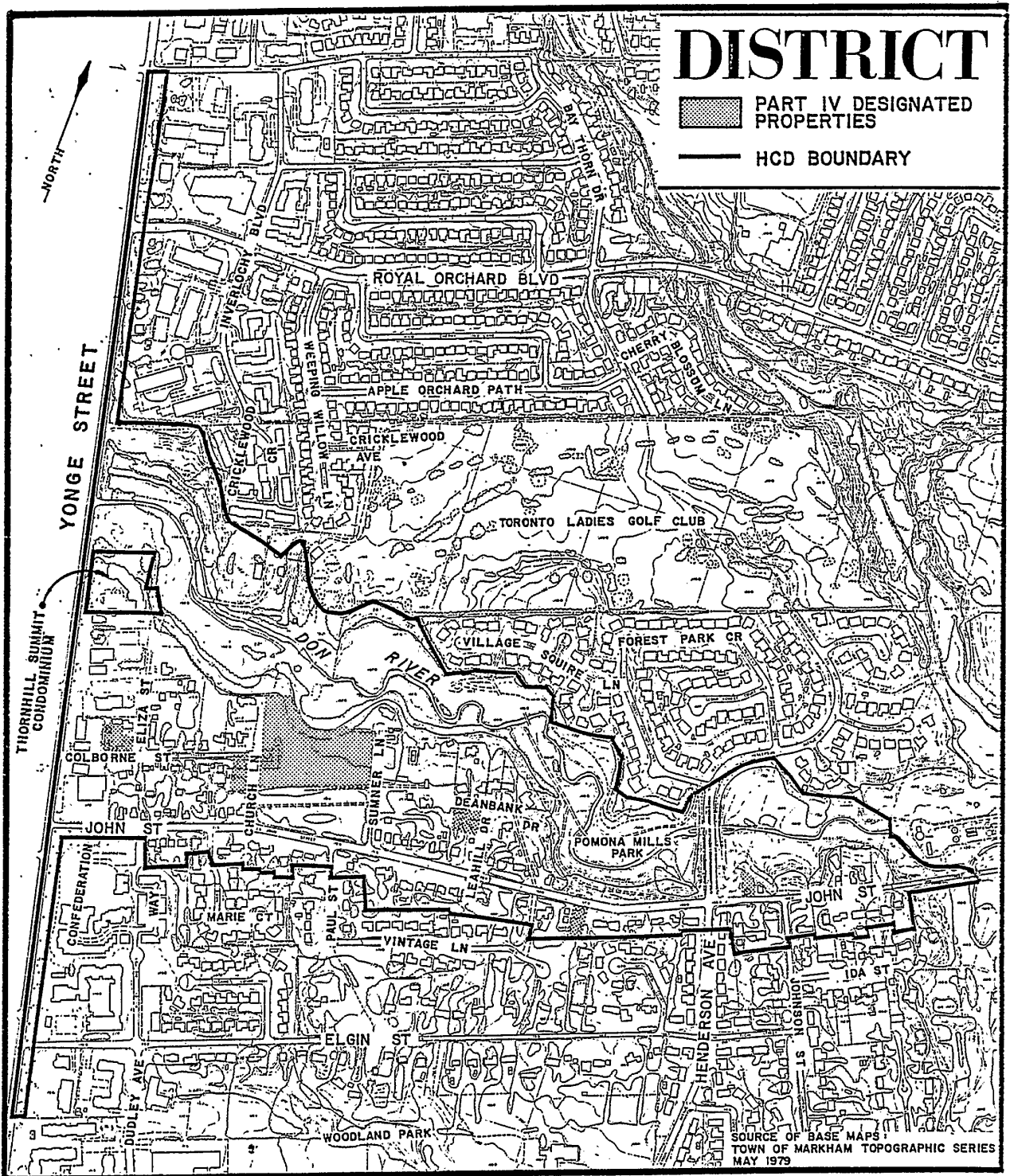
