



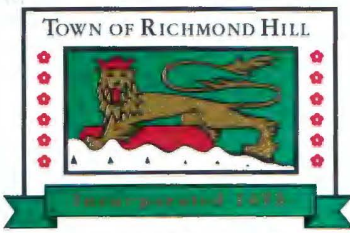

NOTICE OF THE PASSING OF BY-LAW NO. 150-09

TAKE NOTICE that the Council of The Corporation of the Town of Richmond Hill has passed By-law No. 150-09 to designate the following properties, including land and buildings, as properties of cultural heritage value or interest, under Part V of the *Ontario Heritage Act*, R.S.O. 1990, Chapter 0.18.

Property Description: The area generally known as the Hamlet of Gormley, being that area bound by Highway 404 in the east, Stouffville Road in the north, Farmer Court and Part of Lot 35, Concession 3 in the west, and in the south, by a combination of the Canadian National Railway and the rear lot line of those lots fronting onto Gormley Road East and Gormley Court, and to the southeast of the hamlet, the inclusion of the watercourse.


Notice of Objection

Any person who objects to the By-law may appeal to the Ontario Municipal Board by giving the Town Clerk of the Town of Richmond Hill, within 30 days after publication of the notice of by-law, a notice of appeal setting out the objection to the By-law and the reasons in support of the objection, accompanied by the fee prescribed under the *Ontario Municipal Board Act*.
