NOTICE OF PASSAGE OF CITY OF ST. CATHARINES
BY-LAW NO. 2010-241
POWER GLEN HERITAGE CONSERVATION DISTRICT**

TAKE NOTICE that the Council of The Corporation of the City of St. Catharines on August 23rd, 2010, passed By-law No. 2010-241 entitled, "A By-law to designate the Power Glen area of the City of St. Catharines as a heritage conservation district under Part V of the Ontario Heritage Act and to adopt a heritage conservation district plan." for the purpose of designating the Power Glen Heritage Conservation District and adopting a heritage conservation district plan.

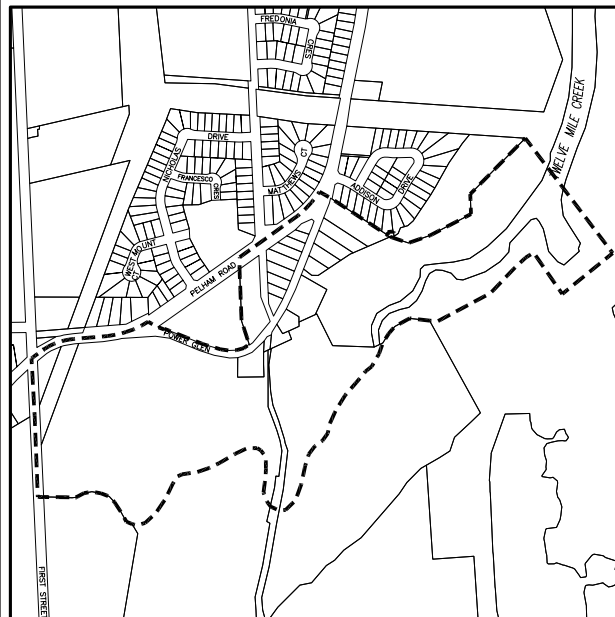
AND FURTHER TAKE NOTICE that any person who objects to the by-law may appeal to the Ontario Municipal Board by giving the City Clerk, within 30 days after the date of publication of notice under clause 41 (4) of the Ontario Heritage Act, a notice of appeal setting out the objection to the by-law and the reasons in support of the objection, accompanied by the fee prescribed under the Ontario Municipal Board Act in the amount of \$125.00. A copy of an appeal form is available from the OMB website at www.omb.gov.on.ca. If the by-law is appealed, the Ontario Municipal Board will make the final decision on this matter.

AND FURTHER TAKE NOTICE that the date of public notice will be September 3rd, 2010, and the last date for giving the City Clerk a notice of appeal is October 4, 2010.

AND FURTHER TAKE NOTICE that the area designated as a heritage conservation district is shown on Schedule A to By-law 2010-241, and the Heritage Conservation District Plan is on Schedule B. A complete copy of By-law No. 2010-241 may be seen in the Office of the City Clerk, or on the City's web page at www.stcatharines.ca.
