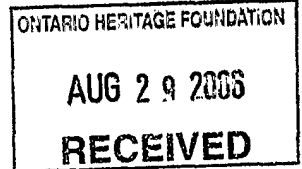

## EXPLANATORY NOTE

The purpose of By-law No. 06-097 is to designate the MacGregor Albert Neighbourhood as a Heritage Conservation District as shown on the attached Map, and to adopt the Heritage Conservation District Plan for the area.

Council has undertaken a Study for the purposes of considering this area as a heritage conservation district. The Study has examined the character and appearance of the area including its buildings, structures, streets, open spaces and other features of the neighbourhood. A Heritage Conservation District Plan has also been prepared which includes policies, guidelines and procedures to conserve and enhance area wide character of the neighbourhood and to guide physical change over time.

Council has approved the Study and the Plan, and recognizes the heritage value and interest of the MacGregor Albert Neighbourhood.

BY-LAW NO. 06-097

BY-LAW TO DESIGNATE A HERITAGE CONSERVATION DISTRICT KNOWN  
AS THE MACGREGOR ALBERT NEIGHBOURHOOD IN THE CITY OF  
WATERLOO

WHEREAS pursuant to subsection 41(1) of The Ontario Heritage Act, R.S.O. 1990, c. O.18, as amended, the Council of a municipality may by by-law designate the municipality or any defined area thereof as a heritage conservation district;

AND WHEREAS the Official Plan of the City of Waterloo contains provisions relating to the establishment of heritage conservation districts;


AND WHEREAS it is intended to designate The MacGregor Albert Neighbourhood defined by the by-law as a heritage conservation district;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF WATERLOO ENACTS AS FOLLOWS:

1. The area shown on Schedule "A" attached hereto and forming part of this by-law is hereby designated as a Heritage Conservation District.
2. The Heritage Conservation District Plan for the MacGregor Albert Neighbourhood prepared by Goldsmith Borgal and Team dated June 15, 2006, as amended, is adopted.
3. This By-law shall come into effect in accordance with section 41 of the Ontario Heritage Act on the day following the last day of the prescribed appeal period or as otherwise provided by subsection 41(10) of the Act.

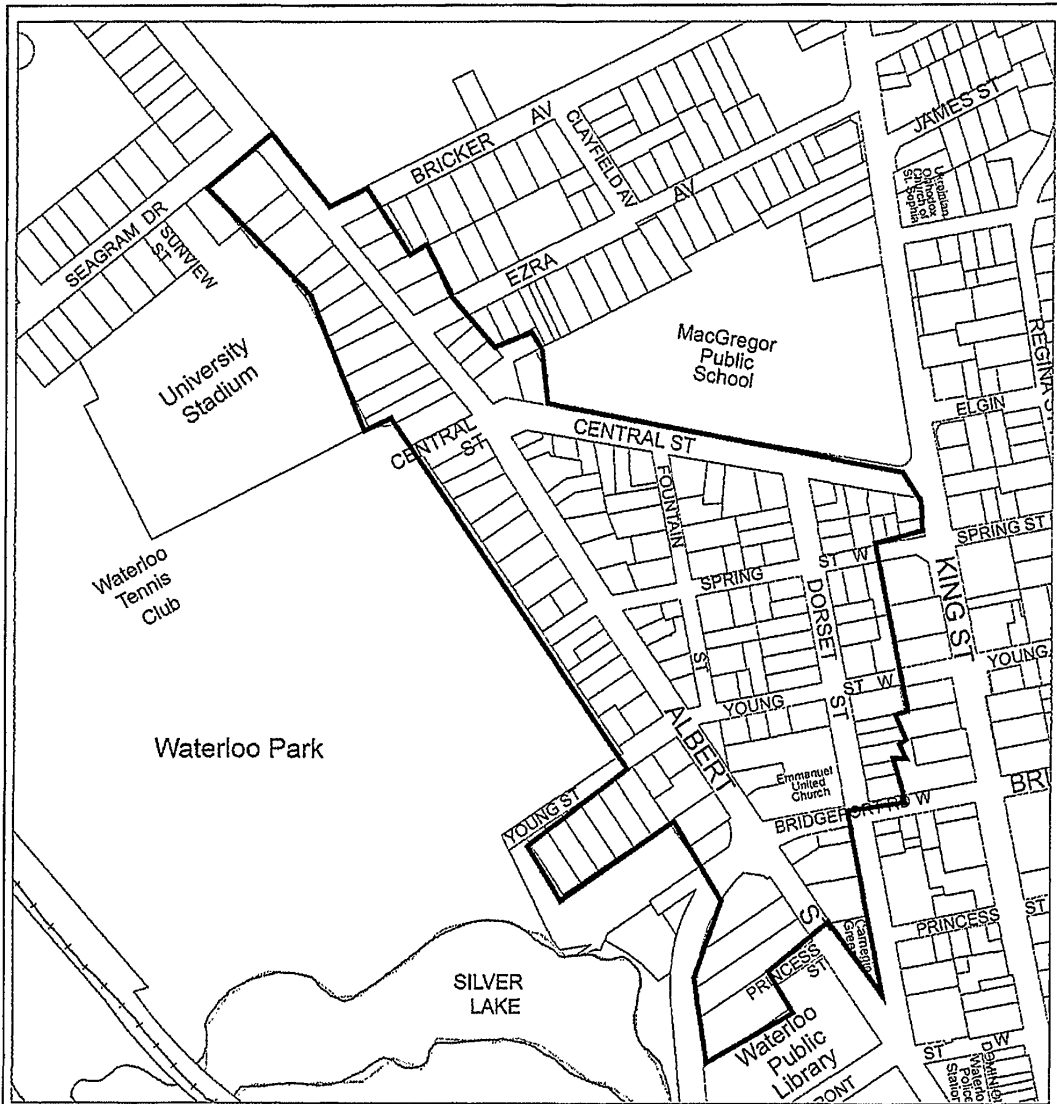
