

TAKE NOTICE that the Council of the Corporation of the Village of Sturgeon Point intends to designate the property, including lands and buildings, at the following municipal address, as a property of architectural and historical value and interest under Part IV of The Ontario Heritage Act, 1974, S. O. Chapter 122.

STURGEON POINT UNION CHURCH 119 IRENE AVENUE VILLAGE OF STURGEON POINT, ONTARIO

Reasons for the Proposed Designation of the Sturgeon Point Union Church, 119 Irene Avenue, in the Village of Sturgeon Point are:

The current Sturgeon Point Union Church was built in 1915, constructed of wood with a shingle roof, in an octagonal plan with gables and with opening windows. The apex of the roof is supported by a central wood pillar terminating in a gothic-style fan at the ceiling which supports the cupola belfry.

This structure replaced a prior building, and has formed the central religious focus for the Village of Sturgeon Point during summer. It is nondenominational, and is important to the community not only for its unique architecture and structure, but also for its historical significance to the development of the Village.

Notice of objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the Village of Sturgeon Point before the 24th day of September, 1993.
