Please be advised that the Council of the Corporation of the Township of Selwyn intends to designate 44 Bridge Street in the Village of Lakefield in accordance with the Ontario Heritage Act, R.S.O. 1990, c.0.18. ## Notice of the Intention to Designate Property Under the Ontario Heritage Act

Take Notice That the Council of the Township of Selwyn plans to pass a By-law on the 13th of April 2021, under Section 29(1) of the Ontario Heritage Act, for the property described as follows:

### **44 Bridge Street (Lakefield)**

44 Bridge Street is an excellent and unique example of a Georgian-style house constructed in stone in Lakefield, Ontario. The house, which was constructed in 1858 and is the only example of this type in the Village, demonstrates the key characteristics of the Georgian-style including the symmetrical three-bay massing and centre hall plan. Despite its later additions, it retains the important elements of this architectural style as it was adapted in North America in the early to mid-nineteenth century. This local landmark holds many key heritage attributes including, but not limited to, granite and limestone construction, gable roof, symmetrically placed chimneys and central entrance.
