## NOTICE OF INTENTION TO DESIGNATE UNDER THE ONTARIO HERITAGE ACT

IN THE MATTER OF THE ONTARIO HERITAGE ACT AND IN THE MATTER OF the lands in the Town of Halton Hills known municipally as 4 Stewarttown Road, legally described as "PT LT 17, CON 7 ESQ, AS IN 581967; S/T 107884 HALTON HILLS/ESQUESING", Regional Municipality of Halton, and known as Harrison-Brown House.

NOTICE IS HEREBY GIVEN that the Town of Halton Hills intends to designate the property at 4 Stewarttown Road, Halton Hills under Section 29(1), Part IV of the Ontario Heritage Act, R.S.O. 1990, Chapter O.18.

## Statement of Cultural Heritage Value or Interest:

The property has been identified as having cultural heritage value as a mid-nineteenth century vernacular building with Georgian influences, with unique dichromatic, locally hand-pressed brick in Flemish bond. The property is associated with early European settler John Harrison and his family, as well as Gordon Oliver Brown. The Harrison-Brown House helps to define and maintain the cultural heritage value of the area and is physically and historically linked to its surroundings.
