THE CORPORATION OF THE TOWN OF BANCROFT

BY-LAW NO. 69-2012

Being a by-law to designate the Umfraville Cemetery as a Heritage Site.

WHEREAS Part IV, Section 29 of the Ontario Heritage Act, R.S.O. 1990, c.O.18, as amended authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of cultural value or interest.

AND WHEREAS the Council ('Council') of the Corporation of the Town of Bancroft ('Town') has determined that the Umfraville Cemetery located on lands described as Part of Lot 20, Old Hastings Road, in the Township of Dungannon, in the Town of Bancroft, in the County of Hastings, and is Part 1 on Registered Plan 21R23761 (the 'Lands') shall be designated as a property of cultural heritage value or interest pursuant to Section IV of the *Ontario Heritage Act*, 1990, c.O.19;

AND WHEREAS Council has caused to be served on the Ontario Heritage Trust notice of intention to so designate the Umfraville Cemetery for the reasons set out in Appendix 'A' attached to this By-law, and has caused such notice of the intention to be published in the local newspaper having general circulation in the municipality;

AND WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the Municipality;

NOW THEREFORE the Council of the Corporation of the Town of Bancroft HEREBY **ENACTS AS FOLLOWS:**

- 1. The property known as the Umfraville Cemetery located on lands described as Part of Lot 20, Old Hastings Road, in the Township of Dungannon, in the Town of Bancroft, in the County of Hastings, and is Part 1 on Registered Plan 21R23761 is designated pursuant to Section IV of the Ontario Heritage Act, as a property of cultural heritage value or interest.
- 2. The Town Solicitor is authorized to cause a copy of this By-law to be registered against the Lands as described in Clause 1 above in the proper Land Registry
- 3. The Clerk is authorized and directed to cause a copy of this By-law to be served on the Ontario Heritage Trust and to cause notice of the passing of this By-law to be published in the local newspaper having general circulation in the municipality.

READ a first, second and third time and finally passed, signed, sealed and numbered By-law 69 -2012 this 13th day of November, 2012.

REASONS FOR DESIGNATION

The council of the Town of Bancroft hereby asserts that the property known municipally as the Umfraville Cemetery is recommended for designation for its cultural heritage value or interest under Part IV of the Ontario Heritage Act. It meets criteria for municipal designation prescribed by Ontario Regulation 9/06 under the three categories of design/physical value,

historical/associative value and contextual value.

Description of Property

The Umfraville Cemetery is an inactive, small, mid to late 19th-century settler cemetery located one a one-acre parcel of land at Old Hastings Rd and Umfraville Road, on Part of Lot 20, in the Township of Dungannon, in the Town of Bancroft, in the County of Hastings, ten kilometers south of the Town of Bancroft.

Statement of Cultural Heritage Value or Interest

The Umfraville Cemetery is the last remaining landmark of the Umfraville settlement in North Hastings, which had a significant population during the second half of the nineteenth century. Settlers, who included the Kelly and Kavanagh families, were granted lands as early as 1852 and the Cemetery appears on record (an 1860 map) as part of a farm belonging to James Kelly. As the first cemetery established in North Hastings, the earliest surviving tombstones date back to 1859. Although the cemetery records were lost in a fire, it is believed that there are as a many as one hundred persons buried there, including many infants and children.

The Bancroft region was settled by a group of very determined people who established the area through mining, lumbering, and farming, and it is important to not only protect this history but to also make it known to the younger generations. It is integral for our current citizens to understand how the region was settled and how much earlier generations contributed to our region. An important aspect of this is the maintenance and ensured longevity of important historical places.

Description of Heritage Attributes

The heritage attributes of the Umfraville Cemetery related to its cultural heritage value as a small, rural burial site of local settlement families, and its influence on the rural character of and value to the community are portrayed by:

- The cemetery's location and dimensions
- The placement of the original markers and monuments at the site
- The mature trees and park like setting in which it is situated
- The variety of styles and material of the original markers and monuments, with their surviving inscriptions
