#### RE: Notice of Decision to Permit Alterations to a Designated Property under Section 33 of the OHA

Please accept this letter as notification, required under Section 33(4)(b) of the Ontario Heritage Act, that Council has recently approved alterations to a designated heritage building, being the Master Mechanical building located at 205 Lakeshore Drive, Barrie and designated through By-Law 91-197. The motion to permit the alteration to this City-owned building attached to this letter.

The proposed alterations include the removal and replacement of a door, door frame, and window frame on the west side of the building. The existing transom will also be removed but will be re-installed following the replacement of the door and window frame.

The alterations are required to address damage caused by vandalism. Further, the door and frame have deteriorated over time as this side of the building faces the westerly prevailing wind and receives more precipitation than other sides of the building.
