Notice of Decision - 100 Bridge Street, Odessa Heritage Permit

Take notice that on May 8, 2023 the Council of Loyalist Township approved a Heritage Permit application to alter a designated property under Part IV, Section 33 of the Ontario Heritage Act for 100 Bridge Street, Odessa.

The recommendation brought forward to Council at the May 8, 2023 meeting was approved with Council passing the following resolution:

That the report from the Development Services Division, May 8, 2023 re: Heritage Permit Application - Booth-Babcock Mill at 100 Bridge Street, Odessa, be received; and that

1. Council approve the submitted Heritage Permit Application to allow work to begin on the clean-up and first phase of restoration of the Booth-Babcock Mill, 100 Bridge Street in Odessa.

The Heritage Permits application was submitted by staff from the Recreation and Facilities Division at Loyalist Township to receive approval for some cleaning and restoration work at 100 Bridge Street, Odessa known as the Booth-Babcock Mill.

The scope of the work is as follows:

- Installation of black mesh wiring to exterior holes to block animals from entering.
- Exterior repointing of limestone cavities (5 total)
- Cementing floor cavity by large double door
- Removal of wasps/hornets nests
- Bird and Squirrel exclusion
- Interior chemical treatments for prevention and control of insect activity
- Exterior Chemical treatments for pest control
- Physical clean-up of interior (removal of debris and insect/animal waste) using vacuum
- Chemical treatment of interior surfaces by animal waste and debris
- Reattachment of study guard by the exterior entrance of the property.

No interior chemical treatments will be used on the machinery.

Neither the Heritage Committee nor Council placed conditions on the approval.
