The last date to file an objection to the proposed designation will be May 23, 1980.

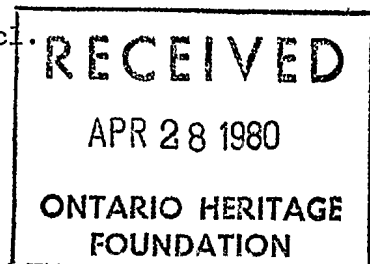

NOTICE OF INTENTION TO DESIGNATE A
PROPERTY UNDER THE ONTARIO HERITAGE ACT

The Council of the Corporation of The Town of Gananoque hereby gives notice that it intends to designate the property of The Gananoque Waterworks Commission on Water Lot H5 fronting on Kate Street in the Town of Gananoque and commonly known as the "Pumphouse" as a property of historic and architectural value or interest.

The reason for the proposed designation is as follows:-

"The Pumphouse is significant, historically, for marking the establishment of the Town's first waterworks system. It is a fine example of deliberately stylized industrial architecture. Of particular interest are the stepped parapet and gables of the St. Lawrence and Kate Street elevations and the two square gable-topped cupolas on the spine of the ribbed metal roof of the main part of the building. Around the windows and other openings are radiating voussoirs with keystones. Windows consist of a multi-paned semi-circular transom separated from the four pane double sash windows below by a dentillated entablature and are anchored by lugsills. Other windows are square headed. The five panelled doors on the Kate St. facade and the twelve panelled doors of the original wing have features similar to the windows. Corbels support the stepped parapets while the rest of the roof is trimmed with a wooden boxed cornice decorated with dentil brackets. The ceiling in the room to the left of the main office has fine wood and decoration in superb condition."

Notice of objection to the designation of the said property may be served upon the Clerk-Administrator of the Town of Gananoque within 30 days of the date of the first publication of this Notice of Intention in the Gananoque Reporter.
