THE CORPORATION OF THE TOWN OF HALDIMAND

BY-LAW # 1030 /93

Being a by-law to amend By-law #689/88 which designates the Olson House as being of historical and architectural value under The Ontario Heritage Act.

---

WHEREAS By-law #689/88 was passed to designate the property known municipally as the Olson House;

AND WHEREAS severances have been approved through Committee of Adjustment decisions dated February 14, 1992, which change the legal description of the original parcel of land;

AND WHEREAS it is now expedient to amend said by-law;

NOW THEREFORE the Council of the Corporation of the Town of Haldimand enacts as follows:

THAT Schedule "B" to by-law #689/88 be amended to read:  
ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Town of Haldimand, in the Regional Municipality of Haldimand-Norfolk, formerly in the geographic Township of Oneida, in the County of Haldimand, and being composed of: Parts 1, 2 and 3 on Reference Plan 18R-3112 save and except Parts 1 through 6 on Reference Plan 18R-4051 together with an easement over Parts 1 and 2 on Reference Plan 18R-4053.

READ a first and second time this 26th day of April, 1993.

READ a third time and finally passed this 26th day of April, 1993.
