THE CORPORATION OF THE TOWNSHIP OF GREY

BY-LAW 33 - 1987

BEING a by-law to designate properties of Architectural and/or Historical significance as Heritage properties under the terms of Part IV of The Ontario Heritage Act, R.S.O., 1980, Chapter 337.

WHEREAS The Ontario Heritage Act, R.S.O. 1980, authorizes the council of a municipality to enact by-laws to designate real property including all the buildings and structures thereon to be of architectural and/or historical significance.

AND WHEREAS the Council of the Corporation of the Township of Grey has determined that the residence located on part lot 16, concession 11, known as the Cameron Residence is of architectural and/or historical significance for the reasons outlined in Schedule "A" attached hereto.

AND WHEREAS the Council of the Corporation of the Township of Grey has cause to be served upon the owners of the lands and premises of the aforesaid property and upon the Ontario Heritage Foundation, Notice of Intention to designate the subject property and has caused such Notice of Intention to be published in a newspaper(s) having general circulation in the municipality once for each of three consecutive weeks.

AND WHEREAS no Notice of Objection to the said proposed designation has been served upon the Clerk of the Municipality.


NOW THEREFORE the Council of the Corporation of the Township of Grey enacts as follows;

- 1) The real property known as the Cameron Residence, located on part lot 16, concession 11, Township of Grey is hereby designated as being of architectural and historical significance.
- 2) The Township Clerk is hereby authorized to cause a copy of this by-law to be registered against the aforesaid property in the proper land registry office.
- 3) The Township Clerk is hereby authorized to cause a copy of this by-law to be served on the owners of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper(s) having general circulation in the Township of Grey once for each of three consecutive weeks.

Read a first time this 19th day of October, 1987.

Read a second time this 19th day of October, 1987.

Read a third and final time and passed this 19th day of October, 1987.

THE CAMERON RESIDENCE

The Cameron residence was constructed by one of the first settlers to the area, Henry A. Mueller, in 1869. In 1875, the farm was purchased by John Cameron Sr. and the farm remained in the Cameron name for over 100 years.

The thirteen room residence was built solidly of limestone from the bed of the nearby Maitland River. A glassed in tower atop the residence along with the six over six windows and limestone blocks gives this building a very solid and unique appearance.
