TOWNSHIP OF CENTRE WELLINGTON

BY-LAW NO. 2006-024

Being a By-law to designate 276 Union Street East  
in the former Town of Fergus,  
to be of cultural heritage value or interest

**WHEREAS** on the advice of the Municipal Heritage Committee, Council has been advised to designate the property noted below to be of cultural heritage value or interest to the provisions of the *Ontario Heritage Act*, R.S.O. 1990, c.O.18;

**AND WHEREAS** the provisions of Section 29, Subsections (1), (2), (3) and (4) have been complied with and no objection has been received by the Municipality.

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CENTRE WELLINGTON HEREBY ENACTS AS FOLLOWS:**

1. The lands and premises described as 276 Union Street East, Plan 154, Part Park Lot 1, S/S Union St. East, Subj. to Easement to Town of Fergus, (Formerly Town of Fergus), now in Township of Centre Wellington are hereby designated to be a building of cultural heritage value or interest.

2. The reasons for the designation are as follows:

**Cultural Heritage Value or Interest:**

Construction of this two storey single detached dwelling is estimated to be around 1880 and features machine made red stretcher brick, a square plan, entry right facade, a belcast roof with gable centre facade, sash windows 6/6 and 4/4 in gable, and a stone basement.

**Heritage Attributes to be protected:**

All exterior brick walls.


Front left façade bay window and 6/6 windows on front façade.


Centre façade gable with 4/4 windows.

Pyramidal roofline.


3. This By-law shall be registered against the title of the lands described 276 Union Street East, Plan 154, Part Park Lot 1, S/S Union St. East, Subj. to Easement to Town of Fergus, (Formerly Town of Fergus), now in Township of Centre Wellington
4. This By-law shall come into force and take effect upon its final passing.


