

THE CORPORATION OF THE CITY OF SAULT STE. MARIE

BY-LAW 94-113

HISTORIC SITES: (L.5.2.7.) A by-law to designate the property at 1186 Queen Street East as being of architectural or historic value or interest.

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1990, c. 0.18 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest; and

WHEREAS the Council of the Corporation of the City of Sault Ste. Marie has caused to be served on the owners of the lands known as 1186 Queen Street East and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality for each of three consecutive weeks; and

WHEREAS no objection to the proposed designation has been served on the Clerk of the municipality;

THEREFORE the Council of the Corporation of the City of Sault Ste. Marie, pursuant to the Ontario Heritage Act ENACTS as follows:

1. PROPERTY DESIGNATED

There is designated as being of architectural or historic value or interest, the property known as:

1186 Queen Street East, more particularly described on Schedule "A" attached to this by-law.

2. EFFECTIVE DATE

This by-law takes effect on the date of its final passing.

SCHEDULE "A" TO BY-LAW 94-113

Composed of a portion of Park Lot number 9 in the First Concession of Park Lots, and may be described as follows:

Commencing at the angle formed by the intersection of the dividing line between Park Lots 8 and 9 with the northerly boundary of Queen Street or Trunk Road;

Thence westerly along the northerly boundary of said Trunk Road 3 chains and 20 links to a post;

Thence North parallel with the dividing line between Lots 8 and 9, 4 chains to a post;

Thence Easterly parallel with said Queen Street or Trunk Road, 3 Chains and 20 links to the Eastern boundary of said Park Lot 9;

Thence southerly along said eastern boundary 4 chains, more or less, to the place of beginning as described in instrument # 446.
