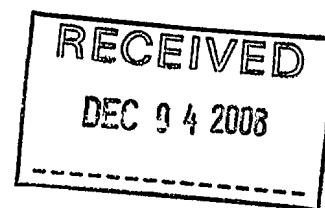

**NOTICE OF INTENTION TO DESIGNATE**

Take notice that the Council of the Corporation of the Township of Centre Wellington intends to designate the property known as the **Fergus Market** located at 105 Queen Street West, Plan 55, Part Lot 2, Mill Lot, N/S Queen St., Pt. Queen Bridge St., Plan 239, Lots A-D, Lane, RP61R1648, Parts 1-3, RP61R5439, Parts 2-3, (formerly in the Town of Fergus), now in the Township of Centre Wellington as property of cultural architectural and/or historical value or interest under Part IV of the *Ontario Heritage Act*, R.S.O. 1990, as amended, (Ch.O.18, Sec. 29)

The Reasons for the Recommendation to Designate are as follows:

Dating from 1879, this building is a prominent local landmark, built as it is at a key intersection on the Provincial highway. Many important architectural details remain intact, including original wooden windows on some of the 'factory' section and most of the 'foundry' section of the building, the striking dentil detailing in the frieze around most of the building, and the integrity of the original stone and brick walls. Another important relic of the building's former manufacturing role is the large cast iron mill wheel still in place in on the ground floor of the building.

Though the first foundry on the site was built by James Grindley, the Beatty Brothers bought the property in 1876, and successor companies continued to operate the growing complex for manufacturing a wide range of products for almost a century.

***What is to be Protected by Designation***

- The large, cast iron mill wheel on the ground floor of the building
- The main brick chimney on the north side of the building
- All exterior stone and brick exterior walls, including existing door and window openings, excepting the most recent (concrete block) expansion of the building to the west
- the interior surfaces and general structure and shape of the 'sawtooth' skylight window system on the roof of the 'factory' section of the building
- the intact St. David street façade of the building
