COMMITTEE RECOMMENDATION

Committee Recommends adoption of the recommendation contained in the following report.

Committee reports having requested the Commissioner of Planning and Buildings to report to Council on the cost of relocating the existing meter.

EXECUTIVE SUMMARY

A request, dated December 9, 1991, for permission for expansion and renovation to the Christian Education Wing of Melville Presbyterian Church was received by this department from Mr. Ken Squires, 12 Irvine Road, Scarborough.

The main church is a designated historical building under By-law 17976. The Ontario Heritage Act requires the request to be circulated to the Local Architectural Conservation Advisory Committee. The request was circulated to the Committee on December 17, 1991, and a response, dated December 19, 1991, was received by this department on January 6, 1992. The Committee had previously reviewed and approved the drawings submitted by the architects, dated June, 1991, at their meeting of July 11, 1991, and requested only that the present gas meter on the west wall be relocated to the north or east wall of the rear section of the church, so that it not be visible on the new west facade.

RECOMMENDATION

That Council give its consent, as required under Section 33(4) of the Ontario Heritage Act, for the expansion and renovation to the Melville Presbyterian Church with the condition that the present gas meter on the west wall be relocated to the north or east wall of the rear section of the church, as per the request of the Local Architectural Conservation Advisory Committee.
