### **NOTICE OF AMENDMENT TO THE DESIGNATION BY-LAW**

TAKE NOTICE THAT THE Council of the Corporation of the Town of Milton intends to amend the designation of the property at the following municipal address as a property of cultural heritage value or interest under Part IV of the Ontario Heritage Act, R.S.O. 1990, c.O. 18, as amended.

**Municipal Address:        Part Lot 5, Con 1, Trafalgar New Survey, Town of Milton municipally known as 5703 Tremaine Road**

### **REASONS FOR THE PROPOSED AMENDED DESIGNATION**

To update the designation by-law to:

- comply with current Provincial government guidance,
- remove inaccuracies,
- provide more information regarding the heritage value of the property; and
- to remove the reference to a partially collapsed cottage so that it can be demolished and a replica built in its place using salvaged materials.

ANY PERSON MAY, within thirty (30) days of the publication of this notice, send by registered mail or deliver to the Clerk of the Corporation of the Town of Milton, notice of his or her objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received by March 10, 2014, the Council of the Corporation of the Town of Milton shall refer the matter to the Conservation Review Board for a hearing.
