TAKE NOTICE that The Ontario Heritage Act, R.S.O., 1990, Chapter 0.18 as amended, provides that the Municipal Council may pass a by-law designating property within the boundaries of the municipality to be of cultural heritage value and interest. The Council of the Municipality of Chatham-Kent hereby gives Notice of the following:

Notice of Passing of By-laws

AND TAKE NOTICE that The Council of the Municipality of Chatham-Kent passed By-law 162-2012 to designate the property known as the Martin House, located at 156-158 Victoria Avenue, in the Community of Chatham (City), legally described as Part of Park Lot 15, Plan 18 As IN 597601, Subject to Easement As IN CK36197 Over Part 1, 24R8718; Chatham-Kent, as a property of cultural heritage value and interest.

AND TAKE NOTICE that The Council of the Municipality of Chatham-Kent passed By-law 163-2012 to designate the property known as the Bell House, located at 8296 Starkweather Line, in the Community of Chatham (Township), legally described as Part of Lot 23, Concession 2 Chatham Gore As IN 564867 (Firstly); Chatham-Kent, as a property of cultural heritage value and interest.

Notice of Intent to Designate

Description of Property:

142 Victoria Avenue, Community of Chatham (City), described as Part of Lot 15, Plan 18 Statement of Cultural Heritage Value or Interest:

The O'Hara House is a well preserved and elegant example of an upper middle class residence with an eclectic mix of architectural elements but principally of Italianate style. The house is of frame construction (presently vinyl sided) with two floors forming an offset "T" footprint with an impressive pillared front porch. The property has direct associations to Robert O'Hara, a prominent early lawyer and horticulturalist, and his son Geoffrey, an internationally renowned composer of popular music in the early 20th century.

Any person may, within 30 days of the date of this Notice, serve on the Clerk, a Notice of Objection in writing, setting out the objection and all relevant facts. Where a Notice of Objection has been served, the Council of the Municipality of Chatham-Kent shall refer the matter to the Conservation Review Board for a hearing.
