Re: Notice of Intention to Amend a Designating By-law - 115 Woodside Avenue

This is to advise that Kitchener City Council, at its meeting of 2003-03-17, directing the Clerk to publish a Notice of Intention to amend By-law 92-242 which designates 115 Woodside Avenue (Harry Class Pool) pursuant to Part IV of the Ontario Heritage Act. The purpose of the amending by-law is to correct the legal description contained in Schedule "A" of By-law 92-242, so as to have the by-law apply only to the lands known municipally as 115 Woodside Avenue. NOTICE OF INTENTION

TAKE NOTICE that the Council of the Corporation of the City of Kitchener intends to pass a by-law to amend Schedule "A" of By-law 92-242 which designates **115 Woodside Avenue (Harry Class Pool)** as being of historic and architectural significance under Part IV of the Ontario Heritage Act, R.S.O. 1990, Chapter O.18, as amended. The amending by-law will correct the legal description of the land designated so as only to apply to the lands known municipally as 115 Woodside Avenue.

Any person may send by Registered Mail or deliver to the Clerk of the City of Kitchener, Notice of his or her objections to the proposed amending by-law, together with a statement of the reasons for the objection and all relevant facts, to be received by the Clerk not later than the 11th day of May 2003. When a Notice of Objection has been received, the Council of the Corporation of the City of Kitchener will refer the matter to the Conservation Review Board for a hearing and report.
