BY-LAW NUMBER 10-94

BEING A BY-LAW TO DESIGNATE THE PROPERTY LOCATED ON CONCESSION 12, PART OF LOT 27, IN THE FORMER TOWNSHIP OF FRANKLIN, NOW IN THE TOWNSHIP OF LAKE OF BAYS; DISTRICT MUNICIPALITY OF MUSKOKA AND KNOWN MUNICIPALLY AS 1195-2 PUT-IN-BAY ROAD AND BEING PROPERTY ROLL NO. 4427 010-003-04000-0000, UNDER PART IV OF THE ONTARIO HERITAGE ACT. (Heritage Designation)(Moffat Property- Korea Cottage)(1195-2 Put-In-Bay Road)

WHEREAS Part IV of the Ontario Heritage Act, R.S.O. 1990, as amended, provides that by-laws may be passed by Council to designate a property within the municipality to be of cultural heritage value or interest;

AND WHEREAS the Moffat Property - Korea Cottage located on Concession 12, Part of Lot 27, in the former Township of Franklin, now in the Township of Lake of Bays, District Municipality of Muskoka and known municipally as 1195-2 Put-In-Bay Road and being Property Roll No. 4427 010-003-04000-0000 has been identified by the Township of Lake of Bays Heritage Advisory Committee as being eligible for designation under Part IV of the Ontario Heritage Act;

AND WHEREAS Notice of Intention to pass a Designation Bylaw was given in accordance with Section 29 of the Ontario Heritage Act in the manner as set out in Schedule "A" of this By-law;

AND WHEREAS the property owner supports the heritage designation process;

AND WHEREAS the Council of the Corporation of the Township of Lake of Bays deems it expedient to designate the Moffat Property - Korea Cottage as a property of cultural heritage value and interest under Part IV of the Ontario Heritage Act;

THEREFORE the Council of the Corporation of the Township of Lake of Bays enacts as follows:

1. THAT the Moffat Property - Korea Cottage located on Concession 12, Part of Lot 27, in the former Township of Franklin, now in the Township of Lake of Bays; District Municipality of Muskoka is a property of significant cultural heritage value and interest.
2. THAT the reasons for designation are hereby included within the Notice of Intention to pass a Designation Bylaw and are attached hereto in Schedule "B".
3. THAT the Clerk shall cause a copy of this By-law, together with its Schedules to be registered against the property in the Land Registrar's Office and shall serve a copy of the By-law together with its Schedules upon the property owner and the Ontario Heritage Trust.
4. THAT the By-law shall take force and effect upon final passage hereof.

NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Township of Lake of Bays intends to designate the following municipal address as being of cultural heritage value or interest under Part IV of the Ontario Heritage Act, R.S.O. 1990, Chapter 0.18, as amended.

1195/2 PUT IN BAY ROAD

Description of Property

Korea Cottage is a one-storey cottage located along the picturesque Springsyde Shore next to Put In Bay on Peninsula Lake in the Township of Lake of Bays.

Statement of Cultural Heritage Value or Interest

The Moffat property was purchased in 1904 with Korea Cottage built in 1915 and has remained in the Moffat family essentially in its original state with limited modifications. The cottage showcases Fredrick William (F.W.) Moffat's industrial craftsmanship that contributed to the continued success of the Moffat family business, "Moffat Stove Company of Weston Limited", within the stove manufacturing industry.

The cultural relevance to the heritage of Muskoka is present in this property as Korea Cottage was one of three properties that was used by the Moffat family to welcome traveling missionaries and their families on furlough during the summer to relax and enjoy the peace and tranquility of the northern landscapes. The name of the cottage demonstrates further contextual value as it represents one of the countries that F.W. Moffat visited and supported through continued humanitarian work and missionary outreach over the span of 40 years.

It exhibits historical associative value through its connection to the Springsyde Path that was used by the first settlers to retrieve mail, food and supplies via steamship from Huntsville. This heritage value is also evident through the Moffat family's continued membership in the Springsyde Cottage's Association since 1905.

As one of the last remaining original cottages along this century-old Springsyde Path, this property represents the lifestyle of the first Peninsula Lake settlers, the early welcoming of tourism in Muskoka and features characteristics unique to the Moffat family history.

Description of Heritage Attributes

Key attributes that express the value of Korea Cottage as an example of the early 20th century style include:

- Interior Features:
 - ✓ Unique enamel-coated iron wood-burning stove fabricated by F.W. Moffat that features hand painted tiles from visiting missionaries;
 - ✓ Original hardwood and softwood floors;
 - ✓ One-of-a-kind household inventions of F.W. Moffat.
- Exterior Features:
 - ✓ One-storey bungalow with gable end roofing;
 - ✓ Awning windows;
 - ✓ Clap-board siding;
 - ✓ Original ice house currently used as a shed;
 - ✓ Adjoined to the century old Springsyde Path;
 - ✓ Growth of hybrid day-lilies developed by international lily expert Bryce Moffat, oldest son of F.W. Moffat.

Objections to the proposed designation must be received by the Clerk of the Township of Lake of Bays by Registered Mail or hand-delivered together with a statement of the reasons for the objection and all relevant facts, not later than **4:00 p.m.** on the **22nd** day of **August 2010**. Objections will be referred to the Conservation Review Board for a hearing and report.
