**CITY OF TORONTO**

**BY-LAW No. 887-2005**

**To designate the Cabbagetown South area as a heritage conservation district.**

WHEREAS City Council, at its meeting of February 16, 17 and 18, 2005, adopted Clause 33 of Toronto and East York Community Council Report 2, and in so doing authorized the passing of a by-law under section 40 of the *Ontario Heritage Act* defining the Cabbagetown South area as an area to be examined for future designation as a heritage conservation district; and

WHEREAS City Council, at its meeting of February 16, 17 and 18, 2005, passed By-law No. 135-2005 defining the study area; and

WHEREAS a heritage study of the area was conducted;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The area outlined by the heavy lines shown on the map attached as Schedule "A" to this by-law is designated as a heritage conservation district under Part V of the *Ontario Heritage Act*, R.S.O. 1990, chapter O.18.
2. The heritage conservation district plan for the Cabbagetown South Heritage Conservation District prepared by City of Toronto Heritage Preservation Services, dated June 2005 is adopted.
3. A copy of the heritage character statement and heritage conservation district plan is available for inspection at the office of Heritage Preservation Services, Planning Division, Suite A17, City Hall, 100 Queen Street West, Toronto, Ontario. It is also available on the City's website @ [www.toronto.ca/heritage-preservation](http://www.toronto.ca/heritage-preservation).

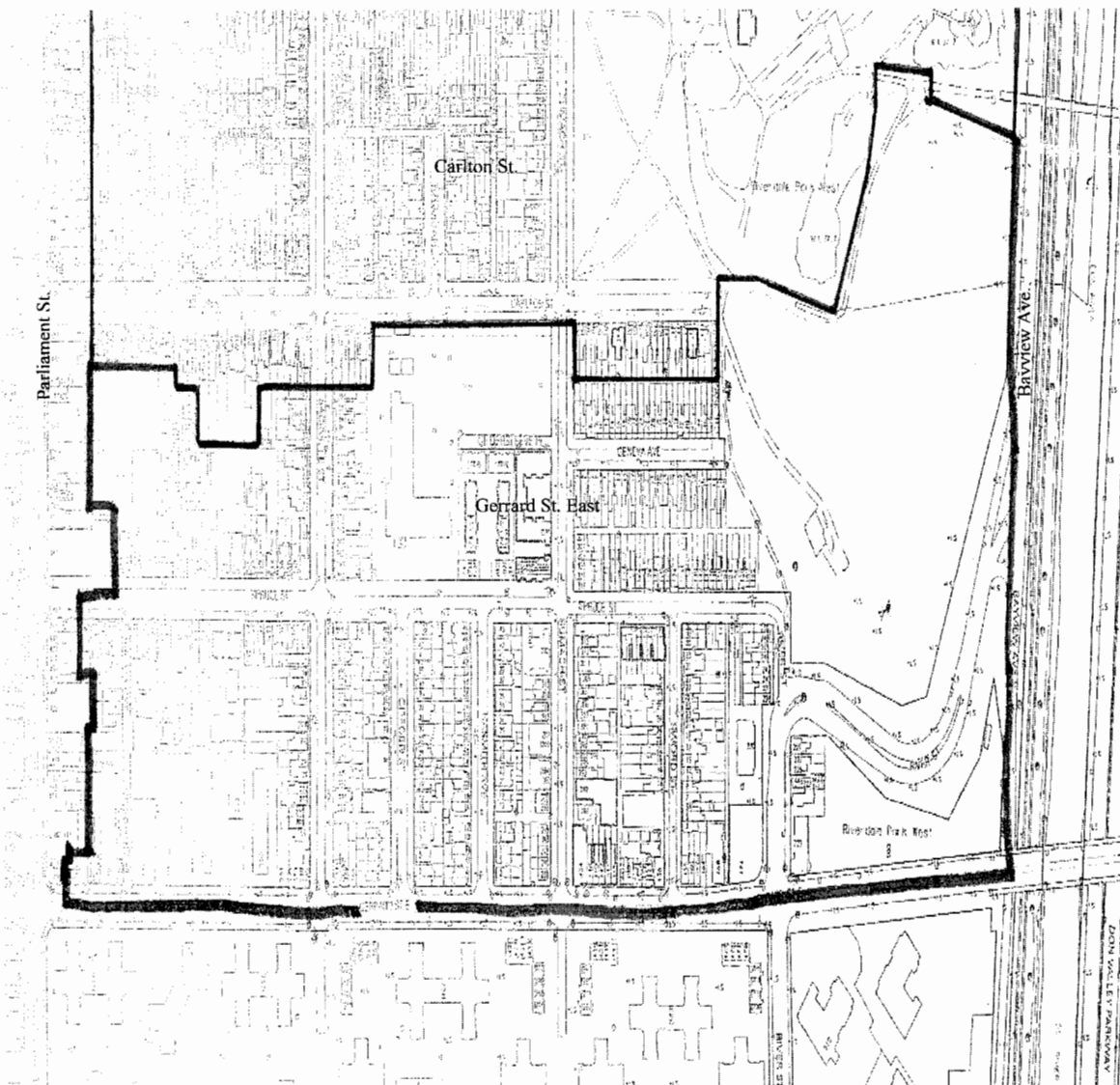

**CABBAGETOWN SOUTH HERITAGE CONSERVATION DISTRICT**



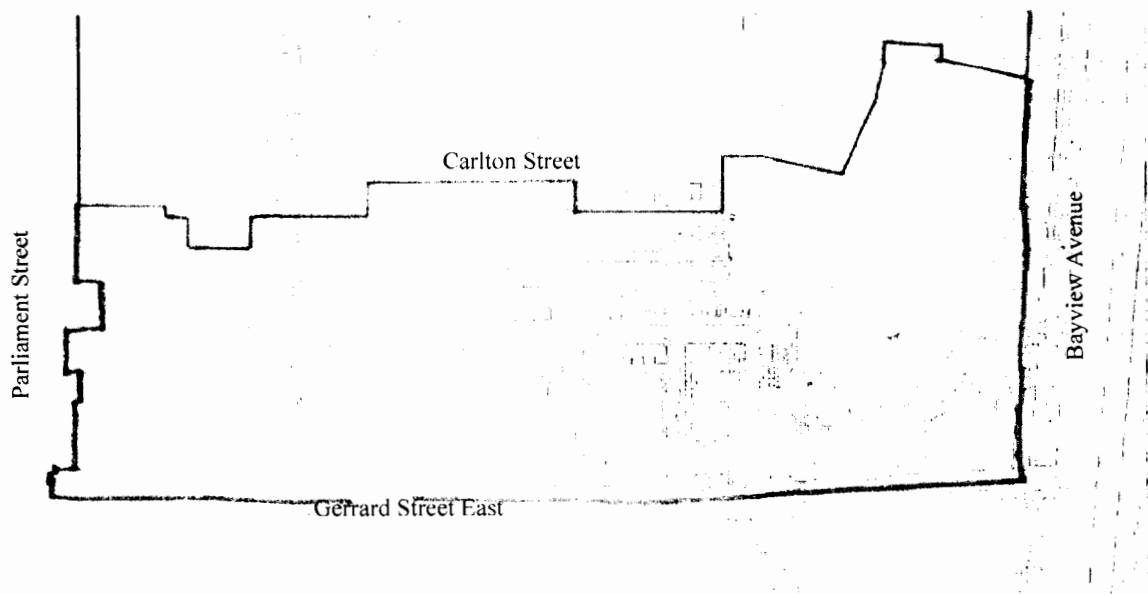


Figure 5. Cabbagetown South Heritage Conservation District
