CORPORATION OF THE VILLAGE OF BARRY'S BAY

BY-LAW NO. 347

. ""

A By-Law to designate property located within the Village of Barry's Bay as being of Historical and Architectural Value to the Heritage of the Village of Barry's Bay

Passed the 7 day of February , 1977.

Whereas certain lands and buildings thereon, within the Village of Barry's Bay and hereinafter described, are deemed to be of historical and architectural significance;

And Whereas in the opinion of the Council of the Corporation of the Village of Barry's Bay, it is expedient and desirable to designate the said property to be of historical and architectural significance;

THEREFORE THE COUNCIL OF THE CORPORATION OF THE VILLAGE OF BARRY'S BAY ENACTS AS FOLLOWS:

- 1. That for the reasons aforesaid, the property including buildings and lands within the Village of Barry's Bay as described in Schedule "A" attached hereto, which schedule forms part of this By-Law, be and the same is hereby proclaimed to be designated in accordance with the provisions of Part 4 of the Ontario Heritage Act and Amendments thereto.
- 2. This By-Law shall come into force and take effect on the day following the final passing thereof by the Council of the Village of Barry's Bay.

SCHEDULE "A"

(1) CNR Water Tank

Location:

All and singular that certain Part of Lot #.182, Range "B" South and the construction situate thereon, known as the "CNR Water Tank", located on Stafford Street in the Village of Barry's Bay.

Historical Significance:

This tank is a remembrance of the logging days in the early part of the 19th Century when trains passed through Barry's Bay quite frequently.

Architectural Significance;

It is one of only two existing wooden water towers of this type in the Province of Ontario.
