## ONTARIO HERITAGE ACT

### NOTICE OF INTENTION

### TO DESIGNATE THE GREEN/KENNEDY/LINDSAY HOUSE

**TAKE NOTICE THAT,** the Council of The Corporation of Norfolk County intends to designate the Green/Kennedy/Lindsay house located on Lot 13, Block P, Plan 19B, municipally known as 126 Main Street South, Waterford, within Norfolk County, as being of cultural heritage value or interest.

The house dates prior to 1873. The board and batten siding became popular after 1850. The three different examples of "gingerbread", the formal entry porch with roof and decorative bargeboard, the roof finials, the elegant pendants, the various eared hood moulds and the moulded battens, all make this house a fine example of the Carpenter Gothic style. This house makes a beautiful architectural contribution along Waterford's historic Main Street and it was the home of Miss Rosse, the "Vegetable Lady", one of Waterford's memorable characters.

Further information respecting the proposed designation is available at the Clerk's Office, Norfolk County Administration Building, 50 Colborne Street South, Simcoe.

Any person who objects to the proposed designation may serve on the Clerk of Norfolk County not later than the 19th day of January, 2009 a notice of objection setting out the reason for objection and all relevant facts.
