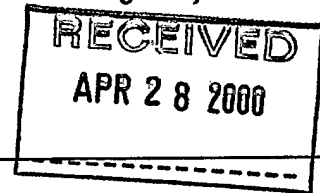

THE CORPORATION OF THE CITY OF MISSISSAUGA

BY-LAW NUMBER *0152-2000*

A by-law to designate the property located at 3790 Derry Road West  
as being of historic value

WHEREAS The Ontario Heritage Act, R.S.O. 1990, Chapter 0.18, as amended,  
authorizes the Council of a municipality to enact by-laws to designate real property  
including all the buildings and structures thereon, to be of architectural value or interest;

AND WHEREAS Notice of Intention to so designate the property located at 3790  
Derry Road West, in the City of Mississauga, has been duly published and served, and no  
notice of objection to such designation has been received by the Clerk of The Corporation  
of the City of Mississauga;

AND WHEREAS the reasons for the said designation are set out as Schedule 'A'  
hereto;

NOW THEREFORE the Council of The Corporation of the City of Mississauga  
ENACTS as follows:

1. That the real property located at 3790 Derry Road West, City of Mississauga, and  
legally described in Schedule 'B' attached hereto, is hereby designated as being of  
historic value under Part IV of The Ontario Heritage Act, R.S.O. 1990, Chapter 0.18,  
as amended.
2. That the City Clerk is hereby authorized to cause a copy of this by-law to be served  
upon the owner of the aforesaid property, and upon the Ontario Heritage  
Foundation, and to cause notice of this by-law to be published in a newspaper  
having general circulation in the City of Mississauga.
3. That Schedules "A" and "B" form an integral part of this by-law.
4. That the Office of the City Solicitor is hereby directed to register a copy of this  
by-law against the property located at 3790 Derry Road West in the proper land  
registry office.

SCHEDULE "A" TO BY-LAW NO. 0152-2000

SHORT STATEMENT OF THE REASONS FOR DESIGNATION

Kindree Family Cemetery, 3790 Derry Road West

A burial ground for children of Nathan and Mary Kindree, this cemetery remained forgotten until the early 1990's when it was found by a housing developer in the area. It lays nestled between trees and next to a tributary of Sixteen Mile Creek. The stones are a testament to the difficulty of life in the early nineteenth century. The weathered stones, in some cases incomprehensible are reminders of the pioneer Kindree family, that settled here in the 1820's. The Kindree's (Kindrae) have their origins in Wales and their travels saw them journey from New Jersey through Niagara and then finally to this rural area now within the boundaries of Mississauga, formerly of Trafalgar Township. The gravestones show that the children died between 1829 and 1839 - three girls died from tuberculosis, the causes of the other deaths are unknown. Father of the deceased children, Nathan Kindree is buried in Eden United Cemetery. Nathan and Mary Kindree had a total of 12 children, five of which survived and raised their own families in the same area. The other seven children are buried within this small cemetery.
