BY-LAW NUMBER 0084-2016

A By-law to designate the Streetsville Public Cemetery
located at 1786 Bristol Road West
as being of cultural heritage value or interest

WHEREAS the *Ontario Heritage Act*, R.S.O. 1990, Chapter O.18, as amended (the "Heritage Act"), authorizes the Council of a municipality to enact By-laws to designate real property including all the buildings and structures thereon, to be of cultural heritage value or interest;

AND WHEREAS Council for The Corporation of the City of Mississauga approved the designation of the property known as Streetsville Public Cemetery located at 1786 Bristol Road West in the city of Mississauga (the "Property") as being of cultural heritage value or interest through Resolution No. 0098-2006;

AND WHEREAS in accordance with the requirements of the Heritage Act, a Notice of Intention to designate the Property was published and served and no notice of objection to such designation was received by the Clerk of The Corporation of the City of Mississauga;

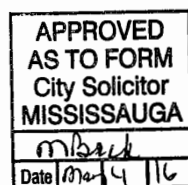
NOW THEREFORE the Council of The Corporation of the City of Mississauga ENACTS as follows:

1. That the property, including all the buildings and structures thereon, known as the Streetsville Public Cemetery located at what is municipally known as 1786 Bristol Road West, in the city of Mississauga and legally described in Schedule 'A' attached hereto (the "Property"), is hereby designated as being of cultural heritage value or interest under Part IV of the *Ontario Heritage Act*, R.S.O. 1990, Chapter O.18, as amended.
2. That the reasons for designating the Property are set out in Schedule 'B'.
3. That the City Clerk is hereby authorized to cause a copy of this By-law to be served upon the owner of the Property and upon the Ontario Heritage Trust and to cause notice of this By-law to be published in a newspaper having general circulation in the city of Mississauga.
4. That the City Solicitor is hereby directed to register a copy of this By-law against the Property in the proper land registry office.
5. That Schedules 'A' and 'B' form an integral part of this By-law.

Summary: All of Lots 2, 3, 6, 8-37, All of George St and All of the 20 Feet Wide Lane & Part of Albert Street and Part of Lots 1, 4, 5 and 7, Registered Plan STR-5

(To be designated under the Ontario Heritage Act)

(Ward 6, City Zone 38W, in the vicinity of Bristol Road West and Durie Road)

Legal Description: In the City of Mississauga, Regional Municipality of Peel, (Geographic Township of Toronto, County of Peel), Province of Ontario and being composed of all of Lots 2, 3, 6, 8-37 (inclusive), all of George Street and all of the 20 Feet Wide Lane and Part of Albert Street and Part of Lots 1, 4, 5 and 7, Registered Plan STR-5, designated as Parts 1 to 12 (inclusive), Plan 43R-36163.

Streetsville Public Cemetery, 1786 Bristol Road West

Description of Property

Streetsville Public Cemetery, 1786 Bristol Road West

Streetsville Public Cemetery is a late nineteenth century cemetery on the east side of the Credit River, south of Bristol Road West.

Statement of Cultural Heritage Value or Interest

Streetsville Public Cemetery is of cultural heritage value as a burying ground for many of the area's earliest pioneers. In use since 1892, the gravesites found in the cemetery provide important insight into the lives of Streetsville's early inhabitants, their descendants and other significant Toronto Township/Mississauga figures including war veterans.

Streetsville Public Cemetery is also of value as an example of late nineteenth century cemetery design that has evolved over time. It is characterized by a naturalistic setting to attract and comfort the living, the creation of a secure space for the dead, the use of markers and monuments to perpetuate the memory of individuals of historic importance and a park-like layout for public use.

The Cemetery is also of cultural heritage value because it is a landmark that defines the east side of Streetsville. It contributes to the naturalism of the Credit Valley corridor and to numerous local vistas because of its location overlooking the east bank of the Credit River. Situated on this historic waterway, next to former and current properties associated with the historic Catholic Church, it contributes to the pious history of the area.

Description of Heritage Attributes

Key attributes of the cemetery that reflect its value as an important link to the history of Streetsville include:

- its original markers and monuments, with their surviving inscriptions and ornamentation
- the variety of styles, materials and symbolism represented in the markers and monuments
- the range of size and sophistication of markers and monuments, from modest to elaborate
- its columbarium

Key attributes of the cemetery that reflect its value as an example of late nineteenth century cemetery design:

- its location, orientation and dimensions
- its monuments, sculptures and structures
- its park-like setting, including its mature trees
- the original plan and placement of gravesites as separate individual markers – they should not be relocated and combined into walls
- the gateway entry (off Bristol Road West) and plaque dedicated to Lenvard Lee

Key attributes of the cemetery that reflect its landmark and contextual value:

- a significant open and green public space overlooking the east bank of the Credit River near former and current Catholic Church sites
- its street façade with gateway
