THE CORPORATION OF THE TOWNSHIP OF WILMOT

BY-LAW NO. 90-14

BY-LAW TO DESIGNATE THE STRUCTURE LOCATED AT PART LOT 7, SOUTH OF ERB'S ROAD, TOWNSHIP OF WILMOT, REGIONAL MUNICIPALITY OF WATERLOO TO BE OF A HISTORIC AND ARCHITECTURAL VALUE AND INTEREST.

WHEREAS Section 29 of The Ontario Heritage Act, R.S.O. 1980 authorizes Council of a Municipality to designate property within the Municipality to be of historic value of interest;

AND WHEREAS Council for The Corporation of the Township of Wilmot deems it desirable to designate the building familiarly known as St. Agatha Catholic School/Shantz's Country Cupboard, St. Agatha, Ontario, to be of historic and architectural value and interest;

AND WHEREAS the Clerk of the Township of Wilmot has caused Notice of Intention to Designate to be given in accordance with Section 29(3) of The Ontario Heritage Act, R.S.O. 1980;

AND WHEREAS no Notice of Objection has been served on the Clerk within the meaning of Section 29(5) of The Ontario Heritage Act, R.S.O. 1980;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF WILMOT ENACTS AS FOLLOWS:

 The property described in Schedule "A" attached hereto is hereby designated to be of historic and architectural value and interest.

2. Section 33 of The Ontario Heritage Act, R.S.O. 1980 shall apply only to the entire north, east and south facades of the stone building including the windows and door surround with stone voussoirs be designated. It is further intended that the stone wall attached to the building and extending within the entire south boundary of the lot for a distance of 177.89 feet be designated.

3. This By-law shall come into effect on the final passing thereof by the Council of the Corporation of the Township of Wilmot.
