NOTICE OF INTENTION TO DESIGNATE

NOTICE IS HEREBY GIVEN that the Council of The Corporation of The Township of Wilmot intends to designate the property at the following municipal address as a property of historic, and architectural significance under the Ontario Heritage Act, R.S.O. 1990 c.O.18, Section 29.

The subject property, familiarly known as the Merner-Shantz-Erwin House, is located at 274 Huron Street, New Hamburg, Part Lot 3, N/S Smith's Plan, Township of Wilmot, Part 2 RP 58R9886 and owned by [REDACTED] [REDACTED] [REDACTED].

The designation is recommended on design, historical and contextual value grounds. Detailed reasons for designation of this property are available at the Office of the Clerk, 60 Snyder's Road West, Baden, On N3A 1A1 during regular business hours (8:30 am to 4:30 pm, Monday to Friday, 519 634-8444). Any person who objects to this intended designation must, within thirty (30) days of the publication of this notice, serve on the Clerk, a notice of objection in writing, setting out the reason for the objection and all relevant facts. The Ontario Heritage Trust provides that where a Notice of Objection has been served, the Council shall refer the matter to the Conservation Review Board for a hearing.
