NOTICE OF INTENTION TO DESIGNATE

NOTICE IS HEREBY GIVEN that the Council of The Corporation of The Township of Wilmot intends to designate the property at the following municipal address as a property of historic, social and contextual value under the Ontario Heritage Act, R.S.O. 1990 c.O.18, Section 29.

The subject property, familiarly known as Livingston Presbyterian Church, is located at 44 Beck Street, Baden, Plan 627 Lot 97 and is owned by The Presbytery of Waterloo-Wellington.

The designation is recommended on design, historical and contextual grounds. Detailed reasons for designation of this property are available at the Office of the Clerk, 60 Snyder's Road West, Baden, On N3A 1A1 during regular business hours (8:30 am to 4:30 pm, Monday to Friday, 519 634-8444). Any person who objects to this intended designation must, within thirty (30) days of the publication of this notice, serve on the Clerk, a notice of objection in writing, setting out the

reason for the objection and all relevant facts. The Ontario Heritage Trust provides that where a Notice of Objection has been served, the Council shall refer the matter to the Conservation Review Board for a hearing.
