



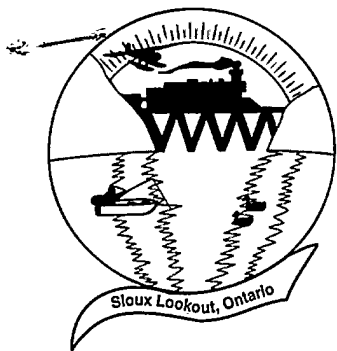

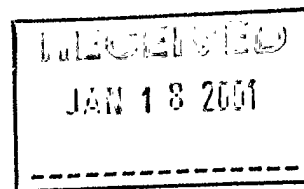

Town of Sioux Lookout intends to designate
the property, including lands and buildings,
at 53 Front Street as a property

interest under Part IV of The Ontario Heritage Act, 1974,
S. 0. Chapter 122

The Sioux Lookout Railway Station was built in 1911 and is
recommended for designation for architectural and historical
reasons. Unlike many railway stations in northern Ontario
communities, this building is Sioux Lookout's first and only
depot. Elongated, simply massed, and modestly ornamented, this
two-story frame station processes a striking architectural
presentation. This station is a tangible example of the early
development of Sioux Lookout
