

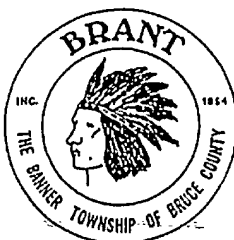

THE CORPORATION OF THE TOWNSHIP OF BRANT

BY-LAW NUMBER 86-1047

BEING a by-law to designate St. John's Lutheran Cemetery.

WHEREAS the Ontario Heritage Act Section 29 (6)(a) (as ammended),
authorizes the Council of a Municipality to enact by-laws
to designate real property to be of historic interest.

AND WHEREAS the Council of the Corporation of the Township of
Brant has caused to be served upon the owner of the lands
known as St. John's Lutheran Cemetery;
And upon the Ontario Heritage Foundation, notice of intention
to designate St. John's Lutheran Cemetery;
And has caused such notice of intention to be published in
a newspaper having general circulation in the municipality.

AND WHEREAS the reasons for designation are set out in Schedule "B"
hereto;

AND WHEREAS no notice of objection to the said proposed designation
has been served upon the Clerk of the Municipality;

NOW THEREFORE the Municipal Council of the Township of Brant enacts
as follows:

- 1) That the real property known municipally as "St. John's Lutheran Cemetery", more particularly described in Schedule "A" attached hereto is designated as being of historic interest.
- 2) That the Clerk be authorized to cause a copy of the by-law to be registered against the property described in Schedule "A" hereto in the proper land registry office.
- 3) That the Clerk be authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having general circulation in the Township of Brant.

READ A FIRST AND SECOND TIME this 2nd day of April, 1986.

Being composed of one half acre on the north east corner of lot number thirty-four in the ninth concession of the Township of Brant as descibed in instrument number 8234 Brant.
