## NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Town of Campbellford intends to designate the property, including lands and buildings, known municipally as 113 Front Street North as a property of architectural and/or historical value or interest under Part IV of the Ontario Heritage Act, 1980.

## Reasons for the Proposed Designation

The building was constructed about 1857 as the Township Hall for the Township of Seymour. It has since served as a Township Hall, Council Chamber, Court Room, Church, School, Jail, Community Centre and Market, and lately as the Public Utilities Commission office.

The one-storey building is constructed of course rubble stone with cut limestone window sills. The windows were arranged three on each side and two on the front elevation. The eaves are returned with a plain freize.

The interior was plastered over wood laths, with the original ceiling being a semi-circular vaulted style, twelve (12) feet in height at the outside walls and seventeen (17) feet high in the centre.

Any person may, before the 5th day of June, 1989, send by registered mail or deliver to the Clerk of the Town of Campbellford notice of his or her objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts. When a Notice of Objection has been received, the Council of the Town of Campbellford will refer the matter to the Conservation Review Board for a hearing and report.
