NOTICE OF WATERMAIN FLUSHING – LINDSAY

The City of Kawartha Lakes wishes to inform the residents of Lindsay that Water and Wastewater Division Distribution Staff will be flushing water mains starting **September 18th, 2017** and continue until **October 31st, 2017**. Cleaning will take place daily from **7:00am to 4:30pm** and Nightly from **8:00pm to 6:00am**.

The flushing of water mains is necessary to remove sediment that gradually deposit in the pipes. There may be brief periods when your water becomes cloudy or discoloured. To clear your water lines, simply let your cold water tap run until the water flows clear. Please check your drinking, cooking and laundry water before using. There may also be temporary pressure fluctuations during flushing.

Public Notice – Notice of the Passing of a Heritage Conservation District Designation By-Law to Adopt a Heritage Conservation District Plan

By-Law No. 2017-182 (Under the Ontario Heritage Act, R.S.O. 1990, c.O.18)

Take Notice that on September 12, 2017, the City of Kawartha Lakes Council adopted By-law 2017-182, which designates Oak Street in Fenelon Falls as a Heritage Conservation District (area shown on attached map) under Part V of the Ontario Heritage Act, and adopts the Oak Street Heritage Conservation District Plan.

The complete by-law, Heritage Conservation District Plan and background Study are available for inspection in the Economic Development Division during regular business hours, 8:30 a.m. to 4:30 p.m., at 180 Kent Street West, Lindsay.

And Take Notice That any person or agency may appeal to the Ontario Municipal Board in respect of the By-Law by filing a Notice of Appeal with the Office of the City Clerk, City of Kawartha Lakes, Attention: Ron Taylor, Acting City Clerk, 26 Francis St., Lindsay, K9V 5R8, no later than 4:30 p.m. on October 23, 2017, setting out the objection to the By-law and the reasons in support of the objection. The Notice of Appeal must be made using an 'Appellant Form' available from the Ontario Municipal Board website at www.omb.gov.on.ca. The appeal must be accompanied by a certified cheque or money order made payable to the Minister of Finance in the amount of \$ 300.00 for each appeal.

The By-law will come into force on October 24, 2017, if no notice of appeal is received on or before October 23, 2017.

No person or agency shall be added as a party to the hearing of an appeal unless, before the By-Law was passed, the person or agency made oral submissions at a public meeting or written submissions to The City of Kawartha Lakes Council or, in the opinion of the Ontario Municipal Board, there are reasonable grounds to add the person or agency as a party.
