

THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 219-90

A by-law to designate the Village
of Churchville as a Heritage
Conservation District

WHEREAS Section 41 of the Ontario Heritage Act, R.S.O.
enables the Council of a municipality to designate by by-law
an area as a Heritage Conservation District where there is
in effect in a municipality an Official Plan that contains
provisions relating to the establishment of Heritage
Conservation Districts;

AND WHEREAS Section 7.12.1 of the Official Plan (1976) of
the City of Brampton contains provisions relating to the
establishment of Heritage Conservation Districts;

AND WHEREAS the Council of the City of Brampton has adopted
the "Churchville Heritage Conservation District Plan";

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF
BRAMPTON ENACTS AS FOLLOWS:

- 1) THAT the area known as the "Churchville Heritage
Conservation District" as illustrated on Schedule 'A'
attached hereto be designated as a Heritage
Conservation District.
- 2) THAT this by-law shall not come into force until
approved by the Ontario Municipal Board.

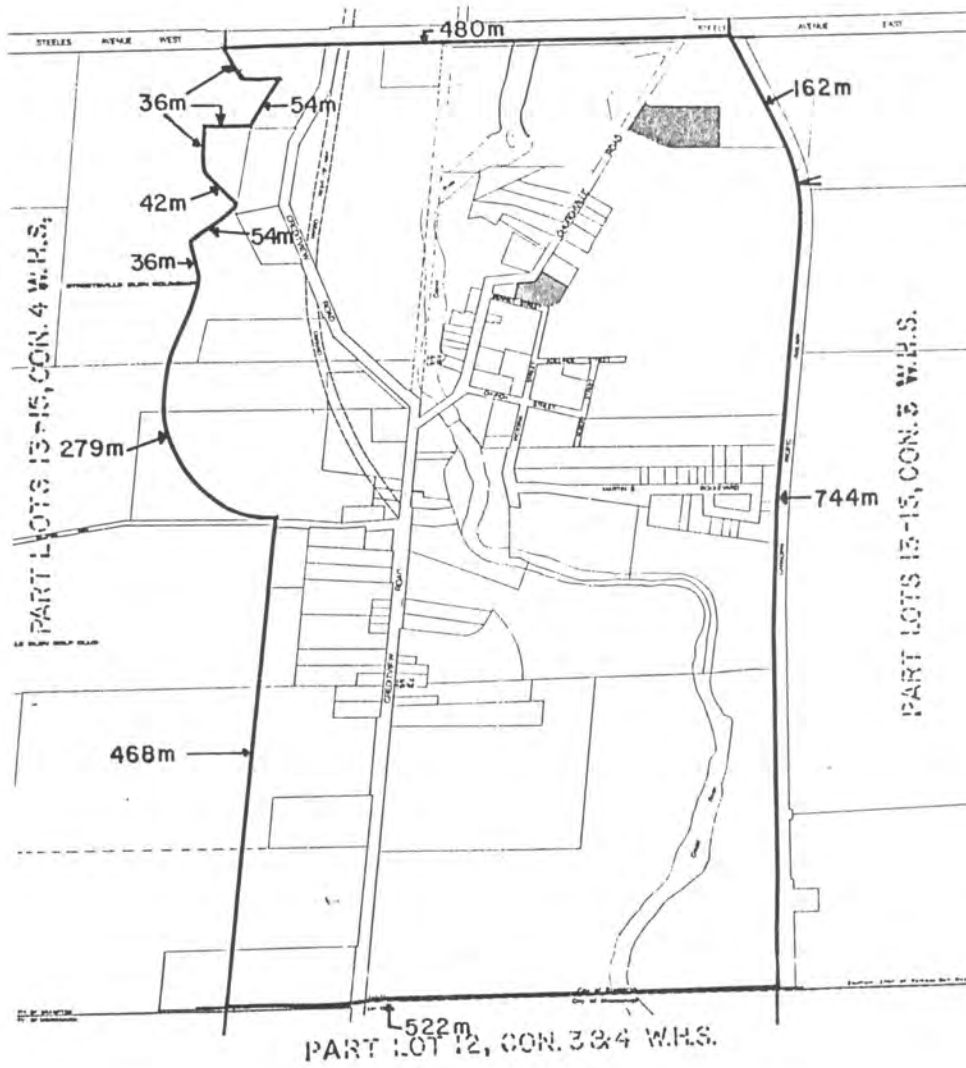
READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN
