A by-law to repeal Designating By-laws 1988-161 (25 Bronte Road), By-law 1987-25 (47 Bronte Road) and By-law 1987-237 (2401- 2405 Ontario Street), pursuant to Subsection 31 of the *Ontario Heritage Act*, R.S.O.1990, c. O.18.

**WHEREAS** Subsection 31 of the Ontario Heritage Act, R.S.O. 1990 c. O.18 authorizes the Council of a municipality to repeal a by-law designating a property; and,

**WHEREAS** the Designating By-laws 1988-161 (25 Bronte Road), By-law 1987-25 (47 Bronte Road) and By-law 1987-237 (2401- 2405 Ontario Street) are being consolidated under a single new by-law, for which Oakville Town Council has issued a Notice of Intention to Designate under Part IV of the Ontario Heritage Act,

**COUNCIL ENACTS AS FOLLOWS:**

1. That By-laws 1988-161 (25 Bronte Road), By-law 1987-25 (47 Bronte Road) and By-law 1987-237 (2401- 2405 Ontario Street) are hereby repealed.
2. This By-law affects the lands described in Schedule "A" to this by-law, being the lands subject to By-law 1988-161, 1987-25 and 1987-237 prior to repeal.

**SCHEDULE "A" TO  
BY-LAW 2013-016**

Land in the Town of Oakville in the Regional Municipality of Halton, more particularly described as follows:

**Land subject to By-law 1987-25 prior to repeal**

Part of Parcel 78-1, Plan M8, being a plan under the *Boundaries Act*, BA-148, designated as Part 1 of Plan 20R-7794

**Land subject to By-law 1987-237 prior to repeal**

Parcel 83-1, Section M-8, being Lots 83 and 85A, Plan M8, being a plan under the *Boundaries Act*, BA-148

**Land subject to By-law 1988-161 prior to repeal:**

Parcel 84-1, Section M-8, being Lot 84, Plan M8, being a plan under the *Boundaries Act*, BA-148.
