THE CORPORATION OF THE TOWN OF CALEDON

BY-LAW NUMBER 2005-029

Being a by-law to designate a certain property, known as the True Blue Masonic Lodge No. 98, as being of cultural heritage value and interest

WHEREAS Section 29 of the *Ontario Heritage Act* authorizes the council of a municipality to enact by-laws to designate property to be of cultural heritage value and interest;

AND WHEREAS the Council for The Corporation of the Town of Caledon has consulted with the municipal heritage committee, Heritage Caledon, with respect to the designation of the property known as the True Blue Masonic Lodge No. 98 as being of cultural heritage value and interest;

AND WHEREAS the Council for The Corporation of the Town of Caledon has caused notice of its intention to designate the foregoing property to be given in accordance with Subsections 29(3) and 29(4) of the *Ontario Heritage Act*;

AND WHEREAS no notice of objection to the designation of the foregoing property has been served on the Clerk for The Corporation of the Town of Caledon;

NOW THEREFORE the Council for The Corporation of the Town of Caledon enacts as follows:

True Blue Masonic Lodge No. 98

There is designated as being of cultural heritage value and interest the property known as:

16 Nancy Street, Bolton, which is more particularly described in Schedule "A" attached hereto.


Reason for Designation

Established in 1858, True Blue Lodge No. 98 is the oldest fraternal order still active in the Town of Caledon. True Blue Lodge's hall on Nancy Street is an excellent example of a Masonic hall of the late Victorian era. In continuous use by True Blue Lodge since its construction in 1876, the hall contributes significantly to the character of this historic streetscape in the core of Bolton. A simple rectangular structure, the hall's exterior reflects alterations from the late 19th and early 20th century while its interior continues to display a high degree of integrity dating to its redecoration in 1889. In addition, a wealth of historic Masonic artifacts, regalia and furnishings, both on display and in use, contribute significantly to the cultural heritage value of the property.

The Clerk is hereby directed to cause a copy of this By-law to be served on the owner of the foregoing property and on the Ontario Heritage Foundation, to cause a copy of this By-law to be registered against the foregoing property in the Land Registry Office and to cause notice of the passing of this By-law to be published in newspapers having general circulation in the municipality for one week only.

Read three times and finally passed in open Council on this 8th day of March, 2005.
