## **CITY OF TORONTO**

### **BY-LAW 507-2021**

**To amend By-law 115-2020, being a by-law to designate the property at  
447-453 Adelaide Street West, to correct a technical error.**

Whereas the Ontario Heritage Act authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of cultural heritage value or interest; and

Whereas authority was granted by Council to designate the property at  
447-453 Adelaide Street West as being of cultural heritage value or interest; and

Whereas Council enacted By-law 115-2020 to designate the property at  
447-453 Adelaide Street West as being of cultural heritage value or interest; and

Whereas it has become necessary to make a technical amendment to correct a typographical error to the legal description for part of the property, being 453 Adelaide Street West in Schedule B of By-law 115-2020; and

Whereas under Section 169-5.2B of City of Toronto Municipal Code Chapter 169, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors;

The Council of the City of Toronto enacts:

1. By-law 115-2020 is amended by deleting the following legal description for the property at 453 Adelaide Street West in Schedule B to By-law 115-2020:

3. The City Solicitor is authorized to cause a copy of this by-law and By-law 115-2020 to be registered against the property described in Schedule A to this by-law in the proper Land Registry Office.
