NOTICE OF INTENT TO DESIGNATE UNDER THE ONTARIO HERITAGE ACT

Re: Notice of Intent to Designate 1050 Rutherford Road pursuant to Part IV, Section 29 of the *Ontario Heritage Act*.

INTENT TO DESIGNATE UNDER THE ONTARIO HERITAGE ACT

Please take notice that the Council of the Corporation of the City of Vaughan intends to designate for reasons of cultural heritage value or interest, pursuant to Part IV, Section 29 of the *Ontario Heritage Act* the property municipally known as **1050 Rutherford Road** in the City of Vaughan, in the Province of Ontario.

REASONS FOR PROPOSED DESIGNATION

Originally built in 1845, the 2-storey plank frame building is a vernacular expression of the Georgian style that continued to be popular well into the first half of the 19th century in Canada. It is a rare surviving example in Vaughan of a wooden frame building from the first half of the 19th century. It remains the only surviving commercial building from that period in the east half of Vaughan.

Originally built by Thomas Cook who was a significant early settler in Vaughan, began a series of enterprises on this property. The Cook brothers are associated with establishing many businesses and expanding Carrville from a small settlement to a thriving village. The property also has associations with Luigi and Rosa Del Brocco, one of the earliest Italian families in Vaughan who converted the structure from a store to a family home in 1919 and lived in the house for 30 years. Stanley Sellen and Ann Crichton-Harris raised their family in the house from 1960-1978. Both individuals were associated with the tv, radio and film industry in Canada.

The property is a longstanding landmark in the history of Vaughan for over 175 years, first as a commercial structure and then as a rural residential property. It is a visual reminder of Vaughan's early settlement from the first half of the 19th century to its transformation to a rural residential property.
