BY-LAW NO. 1992-10

BEING A BY-LAW TO DESIGNATE THE HOME OF **DESIGNATE** AT 803 PRINCES STREET, KINCARDINE, ONTARIO, AS BEING OF HISTORIC OR ARCHITECTURAL VALUE

WHEREAS the Ontario Heritage Act, 1980, authorizes the council of a municipality to enact by-laws to designate real property including all the building and structures thereon, to be of historic or architectural value and interest; and,

WHEREAS the Council of The Corporation of the Town of Kincardine has caused to be served on the owner of the lands and premises known as the home of **Weiner** 803 Princes Street, Kincardine, Ontario; and, upon The Ontario Heritage Foundation notices of intention to so designate the aforesaid property and has caused such notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in a newspaper having general circulation in the municipality once for each to three consecutive weeks; and,

WHEREAS the reasons for designation are set out in Schedule "B" hereto; and,

THEREFORE, the Council of The Corporation of the Town of Kincardine ENACTS as follows:

- 1. There is designated as being of architectural value and interest and real property more particularly described in Schedule "A" hereto, known as the home of 803 Princes Street, Kincardine, Ontario.
- 2. The clerk is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper land registry office.
- 3. The clerk is hereby authorized to cause a copy of the by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having general circulation in the Town of Kincardine.



803 PRINCES STREET

THIS YELLOW BRICK HOUSE IF AN EXAMPLE OF THE GOTHIC REVIVAL STYLE. IT HAS DECORATIVE BARGEBOARD AND A GOTHIC-STYLE WINDOW UNDER THE FRONT GABLE. A VERANDAH SURROUNDS THE WEST AND SOUTH SIDES OF THE BUILDING AND THE FRONT DOOR IS SET OFF WITH RUBY GLASS AROUND IT.
