By-law No. L.S.P.- 2761-140

A by-law to designate 652 Talbot Street of historic and architectural value.

WHEREAS pursuant to The Ontario Heritage Act, R.S.O. 1980, c. 337, the Council of a municipality may by by-law designate a property including buildings and structures thereon to be of historic or architectural value or interest;

AND WHEREAS notice of intention to so designate the property at 652 Talbot Street having been duly published and served, no notice of objection was received to such designation;

BE IT THEREFORE ENACTED by the Municipal Council of The Corporation of the City of London, as follows:

- 1. There is designated as being of historic and architectural value or interest the real property, more particularly described in Schedule "A" hereto, at 652 Talbot Street, for the reasons set out in Schedule "B" hereto.
- 2. The City Clerk is authorized to cause a copy of this by-law to be registered upon the title to the property described in Schedule "A" hereto in the proper Land Registry Office.
- 3. The City Clerk is authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in the London Free Press, and to enter the description of the aforesaid property, the name and address of the registered owner, and short reasons for its designation in the Register of all properties designated under The Ontario Heritage Act, R.S.O. 1980.
- 4. This by-law comes into force on the day it is passed.

Architectural Reasons

The house at 652 Talbot Street is a classical 2 1/2 storey stuccoed building with an elaborate enclosed entranceway, an open verandah bordered by an iron railing, recessed panels and cornice surrounding the first floor. The second floor was added later.

Historical Reasons

William C. Furness, Manager of the Montreal Telegraph Company, owned the property from 1868 until about 1912 when it was purchased by the daughters of Josiah Blackburn of the London Free Press. V. Grace and Susan M. Blackburn, both writers of note, were well known in London's cultural circles.
