

BY-LAW NUMBER 155-2004

BEING A BY-LAW TO REMOVE THE HERITAGE DESIGNATION ON ST. ANDREW'S UNITED CHURCH IN COMBER, TOWN OF LAKESHORE

WHEREAS on January 7, 1980 the former Township of Tilbury West passed By-law Number 1553-01-80 designating under the Ontario Heritage Act, the property known municipally as St. Andrew's United Church, 1933 Main Street, Comber as being of architectural and historical value;

AND WHEREAS on October 26, 2004, the St. Andrew's Parish Council requested the Town of Lakeshore Municipal Council to remove the said Designation;

AND WHEREAS the Municipal Council consented to the request by a resolution that was duly passed on October 26, 2004.

NOW THEREFORE the Council of the Corporation of the Town of Lakeshore enacts as follows:

By-law Number 1553-01-80 of the former Township of Tilbury West is hereby repealed.

This By-law shall come into full force and effect upon the final passing thereof.
