**CITY OF TORONTO**

**BY-LAW No. 110-2002**

**To designate the area bounded generally by Amelia Street, Sackville Street, Carlton Street and Broadcast Lane (Cabbagetown-Metcalf Area) as a Heritage Conservation District.**

WHEREAS City Council, at its meeting of May 11 and 12, 1999, adopted Clause No. 3 of Toronto Community Council Report No. 7, and in so doing authorized the passing of a by-law under section 40 of the *Ontario Heritage Act* defining the Metcalfe Street area as an area to be examined for future designation as a heritage conservation district; and

WHEREAS City Council, at its meeting of May 11 and 12, 1999, passed By-law No. 268-1999 defining the study area; and

WHEREAS a heritage study of the area was subsequently conducted; and

WHEREAS under section 41 of the *Ontario Heritage Act*, no property designated under Part IV of the Act can be designated as part of a heritage conservation district;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Subject to section 2, the area within the heavy lines shown on the map attached to and forming part of this by-law is designated as a heritage conservation district under Part V of the Ontario Heritage Act, R.S.O. 1990, chapter O.18, as amended.
2. The properties shown as "Excluded Lands" on the map attached to and forming part of this by-law, which properties are more particularly described in the following by-laws which designate the properties under Part IV of the Ontario Heritage Act, are excluded from the heritage conservation district created under section 1:
  - A. By-law No. 74-77 of the former City of Toronto.
  - B. By-law No. 116-78 of the former City of Toronto.
  - C. By-law No. 330-81 of the former City of Toronto, as amended by By-law No. 113-92.
  - D. By-law No. 331-81 of the former City of Toronto.
  - E. By-law No. 596-85 of the former City of Toronto.
  - F. By-law No. 69-86 of the former City of Toronto.


3. This by-law shall come into force upon approval by the Ontario Municipal Board.
