## THE CORPORATION OF THE TOWN OF COBOURG

BY-LAW NUMBER 48-86

A BY-LAW TO DESIGNATE THE LANDS AND PREMISES KNOWN MUNICIPALLY AS 136 CHAPEL STREET , IN THE TOWN OF COBOURG IN THE PROVINCE OF ONTARIO.

WHEREAS The Ontario Heritage Act, R.S.O. 1980, Chapter 337, Section 29 authorizes the Council of a municipality to enact by-laws to designate real property including all buildings and structures thereon, to be of architectural and/or historical value or interest;

AND WHEREAS the Municipal Council of the Corporation of the Town of Cobourg has caused to be served on the owners of the lands and premises known as 136 Chapel Street and upon such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks;

AND WHEREAS no notice of objection to the proposed designation has been received;

NOW THEREFORE the Municipal Council of the Corporation of the Town of Cobourg enacts as follows:

- 1. THAT there is designated as being of architectural and historical value or interest the real property known as 136 Chapel Street more particularly described in Schedule "A" hereto.
- 2. THAT a copy of this by-law together with the reasons for the designation be registered against the property described in Schedule "A" hereto in the land registry office.
- THAT a copy of this by-law be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and that notice of the passing of this by-law be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

READ a first, second and third time and finally passed in Open Council this 28th day of April , 1986.

## SCHEDULE "A"

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Town of Cobourg in the County of Northumberland and Province of Ontario, and being part of the west quarter of Lot Fifteen in Concession "A" in the Township of Hamilton, now in the Town of Cobourg, and being the West Forty-one (41') feet of Lots Thirteen and Fifteen in Block "L" and the East foot off the lane along the Western side of said Lots from Chapel Street to the North end of said Town Lot Number Fifteen according to a plan filed by David H. Minaker on November 29th A.D. 1911, as Number 46. Together with a right-of-way for carts, carriages, conveyances and people along the lane shown on said plan, forming the Western boundary of said parcel of land herein above described, in common with owners and occupants of the other lots shown on said plan.

TOGETHER with all the Grantor's right, title and interest in the garage erected at the rear of the premises hereinbefore described and the land upon which the said garage is built.
